

The March meeting of the Beavercreek CPO was held on Wednesday, March 22, 2000, at the Beavercreek Grange on Kamrath Rd at 7:00 p.m.

The guest speakers were:

Peter Angstadt, of Clackamas Community College, asking for support of the Bond measure coming up for a vote in the May Election.

Michael Schauffler, City Commissioner of Happy Valley and a candidate for Clackamas County Commissioner, discussed the needs of the County and his views of what he would do as County Commissioner if elected.

Rob Carnahan, Asst. Chief of Clackamas Fire Dist #1, who answered more questions from the membership regarding the new Beavercreek Fire Station.

Fire Station Update

While the idea to build a new fire station in a different Beavercreek location may seem rather new to some, it is actually a decision that was many years in the making.

Clackamas County Fire District #1 had reason to be concerned about Beavercreek's current facility several years ago. The historical spring break earthquake was a not so gentle reminder that Oregon is at risk for earthquakes. The same was true of fire stations.

A report prepared by Design Edge Services, Inc. in December of 1994, showed that the Beavercreek station was particularly susceptible. The engineers' conclusions recommended changes from the station's roof to its floor. In 1994 dollars, the seismic upgrades required to meet code would have cost the district over \$170,000. Aside from adjustments for inflation, if the district were to pursue these changes now, it would also have to meet new codes enacted since 1994, as well as the new requirements established by the Americans with Disabilities Act. Estimates have placed this new total near \$500,000.

If these were the only challenges facing the Beavercreek station, the district might have pursued an alternative to building a new station in a different location. Unfortunately, the list does not end there. The current site does not have established infrastructure, namely a sewer, and the station is quickly outgrowing the capacity of its current system. The first thought might be to put a sewer at the current location, but the County has determined this is not possible. According to its July 1996 report, the County found that neither a standard nor an alternative on-site subsurface sewage disposal system was feasible for a fire station at this location. This left the district with even fewer options.

It is important to note that the district Board of Director's decision to build a new station was not based solely on the negatives associated with the current location. While the fire service does not cause growth, it does have to deal with it. Emergency service agencies tend to be responsive in nature, but Clackamas County Fire District #1 wants to be ahead of the game in Beavercreek - and growth projections for the area support that a new station would allow the district to better meet the needs of the Beavercreek The case for the district Board's community. decision to move the fire station is a solid one, but it understands that there are some concerns about the future of the station's current location. A 1978 gasoline spill has left its mark on the Beavercreek property. Yet, the most recent tests performed on the groundwater in January show encouraging results. In fact, the Oregon Department of Environmental Quality stated that the site might be a candidate for closure (no longer needing to be monitored by the state) in a

letter to the district earlier this month. The Board has not made a final decision on the future of the current site, but the district has said that it will remain responsible for any impact caused by the spill, and is in the process of preparing the work plan requested by the DEQ as the main criteria to be considered for closure.

Representatives from Clackamas County Fire District #1 will be available to discuss the new Beavercreek station in further detail at the April meeting of the Beavercreek CPO.
