## Early Morning Car Crash Leaves Car Mangled Driver and Passenger Hospitalized

On Saturday, November 14, 2009, at 1:40 a.m. a single vehicle crash occurred in the 25000 block of South Beaver Creek Road (between S. Hereford Road and S. Heft



Loop Road), in Beaver Creek. A resident in the area reporting this incident, informed dispatchers an injured male subject came to her door and alerted the resident of the crash that just occurred --- and that his father remained trapped, unconscious in the vehicle.

Clackamas County Sheriff's Deputies, Beaver Creek Fire personnel, American Medical Response (AMR) and Life Flight, responded to aid the injured and investigate this crash.

An investigating Clackamas County Deputy Sheriff's report indicates a 1994, Lincoln, 2-door sedan, blue in color, is believed to have been traveling southbound on Beaver Creek Road when it failed to negotiate a posted 25 mph curve. This vehicle is considered to have departed the roadway between 67-68 mph and struck a tree situated on the eastside of the roadway.

Beaver Creek Fire rescue personnel were able to extricate the driver from the vehicle; who is identified as Stephen D.

Pitard, age 47, and air lift this patient to Oregon Health Sciences University Hospital, in Portland. Stephen Pitard is reported to have just recently returned to Oregon from

the State of Florida, where he had been residing. Stephen Pitard remains hospitalized and in CRITICAL CONDITION with massive head injuries.

The passenger and son of the driver is identified as Shayne A. Pitard, age 23, who resides on South Lower Highland Road, in Beavercreek. Shayne Pitard was able to exit from the crashed vehicle and walk to a residence to summon help. Shayne Pitard was then transported by an AMR ambulance to Oregon Health Sciences University Hospital, where he was being treated for a non-life threatening head injury sustained in the crash.

Alcohol and speed are being considered as contributing factors in this ongoing traffic crash investigation.

Dear Friends,

Tonight (Nov. 7, 2009) I cast a historic vote to overhaul America's failing healthcare system to improve the healthcare of all Americans. This bill prohibits exclusions based on preexisting conditions and ensures American families will no longer be one illness or job loss away from bankruptcy. It also protects America's senior citizens by fixing the donut hole sooner and allowing more drug price-negotiation to ensure seniors are getting the best prices for their medications. For the first time in our nation's history, we will say that every American deserves access to affordable quality healthcare.

I also believe that controlling escalating healthcare costs is essential to getting our nation's fiscal picture under control. ## Huge, New Digital Images of Oregon Show Stunning Detail of The Landscape

Using a new laser based terrain mapping program called Lidar (light detection and ranging), the Oregon Department of Geology and Mineral Industries (DOGAMI) has released new, unique, full color images of Mount Hood, the Columbia Gorge and the Portland Basin.

"One of the things that makes these new images so amazing is the amount of detail you see on an image this size (5 feet by 6 feet and larger)," said James Roddey, Earth Sciences Information Officer with DOGAMI. "Another thing that makes these images so stunning is our ability to manipulate the data that goes into creating the image. You can strip away all the vegetation and buildings so you're left with a 'bare earth' view of the ground that is the most accurate representation of the landscape that has ever been seen."

The three new poster sized images, all created by Ian Madin, Chief Scientist with DOGAMI, are:

Open-File Report O-09-07, Lidar Mosaic Imagery of Mount Hood and Surrounding Area, Oregon (60 x 72 inches);

Open-File Report O-09-08, Lidar Mosaic Imagery of the Columbia River Gorge, Multnomah Falls to Cascade Locks, Oregon (60 x 84 inches);

Open-File Report O-09-09, Lidar Mosaic Imagery of the Portland Basin, Oregon and Washington (60 x 96 inches).

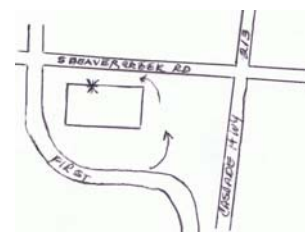

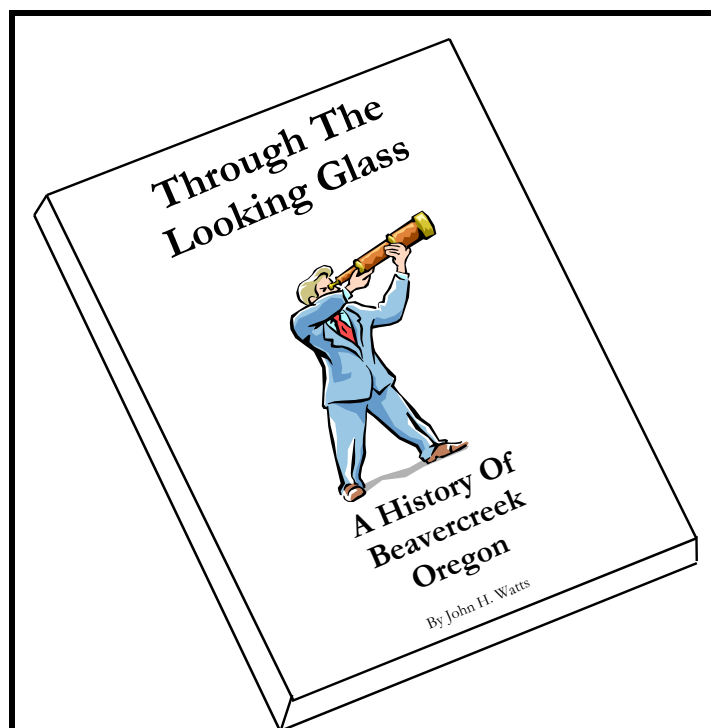

## Concrete Barrier Forced Into Opposite Lanes of I-205 During Morning Crash

A driver was cited Friday morning following a multi-vehicle crash on Interstate 205 north of Oregon City in which the center concrete barrier was struck and pushed



into the opposite lane of travel. A total of five vehicles were involved, two northbound and three southbound.

According to OSP Trooper Colin Tracy, on November 13, 2009, at approximately 8:40 a.m. a 2002 Toyota

Camry driven by Jacqueline Wischmeyer, age 67, from West Linn, was northbound on Interstate 205 in the left lane near milepost 9. A 2007 Kenworth truck driven by Robert A. 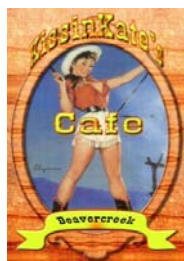

program is to assist low income workers in expanding their skills, allowing them to seek work in occupations that provide higher wages.

To be in the program, an individual must qualify for an unemployment claim based on wages of less than \$9.24 an hour. In addition, the individual must be attending training designed to prepare him or her for employment in jobs that are in high demand, and where wages are at least \$9.24 per hour.

The program does not pay for the training or provide benefits for individuals in training intended to lead to a baccalaureate or higher degree.

"This is one of the many actions taken this legislative session to help Oregon families during this difficult time," said Governor Ted Kulongoski. "This new program will help Oregonians in two critical ways - first with continued financial assistance to help meet their family's basic needs and by providing an opportunity to gain a new skill that will lead to longer term economic security."

The new program was created by the Oregon Legislature in House Bill 3483. The program runs from November 1, 2009 to January 1, 2012.

The Oregon Employment Department estimates 2,400 workers will participate in this program each year.

"Consumers should be aware that stand-alone Medicare prescription drug plans and Medicare Advantage plans change their premium and coverage each year," said Lisa Emerson, manager of the state's Senior Health Insurance Benefits Assistance (SHIBA) program. "In today's economy, saving money could not be more important so it is wise to conduct an annual review of your health benefits."

The SHIBA program, part of the Department of Consumer and Business Services, trains volunteers throughout Oregon to help people compare insurance options and

Many others will want to shop as they see plan prices go up or find out that a drug they take is no longer covered by their plan. blade repair technicians. The curriculum will likely lead to national certification for blade repair technicians through the American Composites Manufacturing Association, according to Gayle O'Toole, project coordinator in CCC's Customized Training and Development Services.

"We're building a new program to address an emerging need – growing jobs in a new area," O'Toole said. "We are not aware of another community college in the country that is offering this program."

CCC will work closely with Miles Fiberglass and Composites in southeast Portland. Miles started working with companies in the wind industry about three years ago, training technicians to travel around the country to repair wind turbine blades. The need for the repair technicians at Miles is expected to increase by 30 to 40 percent in the next year, according to Lori Luchak, president of Miles Fiberglass.

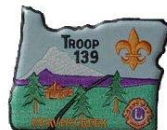

## OSP Trooper Cites Sandy Man Following Illegal Killing of Large Blacktail Deer

An Oregon State Police (OSP) Fish & Wildlife trooper cited a Sandy man on charges related to the unlawful shooting of a large 4 point Blacktail deer on another person's property near Sandy.

On October 31, 2009 at approximately 12 noon OSP

Trooper Mathew Fromme responded to a trespassing and hunting complaint on private property in the area of SE Ten Eyck Road near Roslyn Lake north of Sandy. Witnesses reported seeing a man in a Toyota pickup stop, get out and move to a fence from where he shot a large blacktail deer that was on private property with a doe deer. The man then moved his pickup to a second location, walked onto the private property to the dead deer and dragged it back to the pickup before leaving the area.

Witnesses were able to obtain a license plate and provided it to the trooper. The registration showed the pickup belonged to a nearby resident named Lamont Coleman, age 45.

After completing witness interviews, Trooper Fromme went to Coleman's residence and spotted the pickup in a treed area behind the residence. Upon contact, Trooper Fromme saw Coleman was in the process of gutting the deer.

Subsequent to the investigation, Coleman was cited to appear in Clackamas County Circuit Court for two class A misdemeanor offenses:

Trespassing with a Firearm

Hunting on the Enclosed Land of Another

The deer and rifle were seized. The deer meat is to be processed and donated to the Portland Rescue Mission.

The deer is to be taken to a Boone and Crockett recognized taxidermist for an antler measurement.

## Natural Gas Leak Update

Clackamas Fire crews were dispatched on November 18, 2009, at 8:54 a.m. to the scene of a natural gas line dig in that occurred on Warner-Milne Road in Oregon City between Molalla Ave. and Beavercreek Road.

A privately contracted construction crew working on Warner-Milne Road, accidentally broke loose a 1" natural gas line with a backhoe that was directly connected to a 4" main line. It was originally reported that the 4" line was broken; this ended up not being accurate.

Northwest Natural crews arrived on scene quickly to assess the damage. It was determined that additional repair time was needed due to damage to the 4" main that was connected to the 1" line.

The priority of all entities involved was the safety of the public and the responding crews. Therefore as a precaution, evacuations of the businesses and homes in the area began as soon as Clackamas Fire crews arrived on scene. Clackamas Fire established a perimeter around the incident for three blocks in all directions. There were about 30 people and eight structures that were involved in the evacuation, including the Oregon City Police Department.

Oregon City Police and Gladstone Fire assisted Clackamas Fire crews on scene with this incident. There were no injuries and Northwest Natural Crews were able to repair the broken line without incident.

The line was officially repaired at 1:30 p.m. Prior to allowing access to the evacuated buildings, all properties were

inspected with highly sensitive air monitors to ensure no natural gas registered and the situation was safe.

Please remember to always have a locate service verify and mark all utilities before you do any digging on your property by calling 811. If you ever smell the "rotten egg" smell in your area, you should immediately call 911.

## Sewage Leak At Oregon City Wastewater Treatment Plant Due To Power Outage

A power outage at an Oregon City wastewater treatment plant caused the discharge of raw sewage into the Willamette River Sunday, November 22nd. The outage began at about 11:19 a.m. and caused the shutdown of the entire plant. An estimated 3 million gallons of sewage was dumped into the river.

The power outage affected Tri-City Water Pollution Control Plant which serves the cities of West Linn, Oregon City and Gladstone. The cause of the power outage is unknown. Portland General Electric crews worked to restore power.

Officials at the State Department of Environmental Quality and the Oregon Emergency Response System. Signs were posted in the area about the spill. None of the sewage had leaked onto land, all was being discharged through piping into the river.

From 2004 through 2008 in Oregon there were 2,899 home heating-related fires resulting in 12 deaths, 85 injuries, and more than \$42 million in property loss. These heating-related fires also resulted in 34 injuries to firefighters.

"Homeowners need to have the chimneys and flues on their fireplace and woodstoves cleaned and inspected annually," said State Fire Marshal Randy Simpson. "Also be sure to give heaters their space, keeping them three feet away from combustible materials."

Oregonians can keep themselves safe by following these home heating safety tips:

#### **Fireplaces and Woodstoves -**

Have chimney and woodstove flues inspected and cleaned each year by a qualified chimney sweep. Ask them to check for creosote deposits, soot build-up, or physical damage.

Always use a fireplace screen. Make sure the screen is made of sturdy metal or heat-tempered glass to prevent sparks from escaping.

Keep a clutter free environment. Store kindling, fire logs, and wood at least three feet from any heat source.

Dispose of ashes in a metal container and place the container outdoors at least three feet from anything flammable. Ashes may retain heat for days after they appear out.

#### **Portable Space Heaters -**

When using portable heaters make sure they come with an automatic tip-over switch and a high temperature limit switch. The tip-over switch turns the heater off if it is knocked over. The high temperature limit switch regulates the heater preventing it from overheating.

Give heaters space. Keep at least three feet of space between the heater and combustibles such as furniture, curtains, papers, and people.

Check heater electrical cords. If the cord is frayed, cracked, or becomes hot have it serviced.

Never use extension cords with portable electric heaters. It can overload the circuit and cause a fire.

Unplug heaters when not in use or before going to bed.

#### **Electric baseboard and wall heaters -**

Be aware of electric baseboard or wall heaters. These heaters are thermostatically controlled and turn on without warning when temperatures drop. Keep combustibles at least three feet from these types of heaters.

#### **Propane appliances -**

If using a propane-fueled heater, make sure it is designed for indoor use. Read all of the manufacturer's instructions and make sure it is properly vented.

Do not use barbecues indoors for heating or cooking.

Make sure propane-fueled appliances are properly vented and follow all manufacturers' instructions.

If you smell gas, do not operate any switches, appliances, or thermostats. A spark from one of these could ignite the gas. Get everyone outside and away from the building. Shut off the gas supply. Call your propane supplier from a neighbor's phone.

Avoid kerosene heaters. They can emit poisonous fumes.

#### **Smoke alarms and home escape plans -**

Working smoke alarms alert you to a fire and more than double your chances of surviving a fire. In a fire, minutes could mean the difference between life and death.

Install smoke alarms in every home, on every level, outside each sleeping area and in each bedroom.

Test and vacuum your smoke alarms each month to make sure they are working.

Smoke alarms 8 to 10 years old or older should be replaced.

Make a home escape plan and practice it with your family at least twice a year.

#### **Carbon Monoxide dangers -**

Home heating and cooking equipment that burn fuels such as gasoline, wood, coal, natural gas, propane, oil and methane are sources of carbon monoxide.

Carbon monoxide poisoning can be fatal if not detected early.

If you burn one of these fuels for home heating, make sure your carbon monoxide alarm is working properly.

## Duplicates Will Safeguard Future Oregon City Meeting Videos

### Private Sessions

*The City Commission takes steps to comply with state law*

After dumping years' worth of meeting records in apparent violation of state law, Oregon City has established policy to make sure records of closed but official meetings are properly made and retained.

Videotapes of the meetings will now be duplicated onto DVDs and kept for 10 years, according to City Recorder Nancy Ide. Copies also will be kept on the city computer server and the server of the company that provides Web-streaming of city meetings.

Oregon law permits public agencies to hold private meetings, called executive sessions, in certain situations where public disclosure could have harmful effects, such as discussions of personnel matters, real estate purchases or litigation. Although the meetings are private, government agencies must keep records of them.

Oregon City's failure to keep proper records became an issue during the summer when Commissioner James Nikita, seeking to research an issue, discovered that the tapes of four meetings were blank.

Ide determined that the tapes were blank because of operator error — the city's regular video technician was on vacation.

Nikita also discovered the tapes of 200 meetings from between 1992 and 2005 had been destroyed in apparent violation of state law.

Oregon law permits the tapes of executive sessions to be destroyed one year after minutes have been prepared and approved, provided that those minutes "give a true reflection of the matters discussed at the meeting and the views of the participants."

The city has brief notes of those meetings but not detailed minutes.

Ide questioned how the commission would approve the minutes of the executive session without doing so in public session, which, she said, would make them part of the public record.

She said that when she called the State Archives Office with this question, "their response was that each city should create its own policy on how to approve the executive session meetings."

The city now keeps multiple copies of each meeting, both on DVD and electronically, and has retained someone to compile minutes in a timely fashion.

At a recent City Commission meeting, Commissioner Doug Neeley dismissed allegations that there had been anything willfully criminal in the destruction of the tapes.

"We are now going to make sure that we do a better job of keeping things," he said.

Nikita continues to pursue the question of whether there was wrongdoing in the destruction of the tapes, writing letters to law enforcement officials and the State Ethics Board. He has not, though, filed any formal complaint.

"This is the hardest issue I've had to deal with since joining the City Commission," he said. "This is not just a question of being able to check on how a topic was dealt with. It's a question of keeping a history for future generations, to allow us to go back and see how decisions were made, how ideas about how our city has developed have evolved."

There was only one land use application before the attendees. It was a renewal of a Home Occupation Permit to park excavation equipment for work off-site. The application was approved.

It was shared with those present that the Lazy S application, that was heard at a previous meeting, had been approved with conditions as had the Samson Estate development across from the Saloon.

Various committee reports were given including one by Larry Church of the Transportation Committee. A copy of a letter from the City of Oregon City to the County's Traffic Engineering Supervisor requesting an Oregon Department of Transportation speed study was passed out. The study was requested to help justify a new posted speed limit of 40 MPH on S. Beavercreek Road between S. Loder Road and the City limits (approx. 900 ft. South of Glen Oak Road).

This caused various discussions as the Hamlet had requested the speed limit be changed to 35 MPH for the same stretch of road. If the speed limit is changed the 20 MPH speed limit would be removed.



It was also announced that the "round-a-bout" requested for the S Beavercreek/Kamrath/Leland Road intersection is on the near term list for road improvements. The cost would be about one million dollars. The Hamlet submitted the request months ago. It is hoped it will slow down the speeding through the core area and out Kamrath Road as well as lower traffic accidents, but also facilitate the movement of

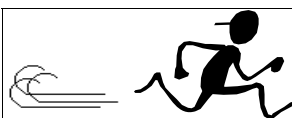

Bill Merchant asked if we should set up a Tourism Committee to discuss and promote the Beavercreek areas various tourist attractions.

Christie Kosinski reported on the Road Standards that the County is revising for the first time in many years. Also her concerns about the County spending money to paint the Holly Lane bridge at a cost of \$250,000.00 to \$350,000.00 when the bridge is slated to be torn down if other improvements on Holly Lane are made. If it is painted Holly Lane will be closed at the bridge for about a month. Residents have been notified.

Christine also reported that the County was meeting with DOGAMI to do Lidar maps including the Hamlet of Beavercreek. The Holly Lane map that has already been done is the first in the quadrangle to be completed.

Christine was commended on the work she has done on behalf of the community. Her diligence in attending all the meetings and talking with officials was recognized. Without her untiring efforts the Lidar mapping to show ancient land-slides for our area probably would not have been started.

It was noted that again, there have been last minutes additions made to the area recommended for urbanization by Oregon City. This is the second time this has happened in the Urban/Rural Reserve process. Everything that had been discussed and had a chance for citizen input was summa-
