During its October 21, 2015 meeting, the Clackamas Community College Board of Directors passed the second reading of a resolution adopting the Oregon City Campus master plan.

package were the three buildings at the Oregon City Campus (a science building expansion, Student Services Community Commons replacement and the new Industrial Technical Center), infrastructure improvements and major maintenance. Since the passage of the bond, the college hired an architect for the master plan.

The master plan identifies the location of the Industrial Technical Center, DeJardin Phase II and the Student Services Community Commons building, along with options for Automotive Science and remodels in Barlow Hall, McLoughlin Halls and the Pauling Science Building C.

These buildings will allow CCC to grow and will ensure students will have opportunities for in-demand, living-wage jobs and to pursue transfer degrees. The projects will also allow students to complete a two-year degree at any of the three CCC campuses.

Infrastructure and major maintenance items are also identified. The plan lists improvements at the Environ-

mental Learning Center and potential partnerships resulting in a wrestling facility, an arboriculture facility and a location of enhanced Clackamas County Fire District training area.

CCC provides career technical programs, college transfer degrees and basic skills education, along with workforce and business services, job training and community education classes. The college serves more than 30,000 students per year.

### CCC Named Top College For Veterans

Military Times has named Clackamas Community College as one of the best in the nation for veterans in its Best for Vets: Colleges 2016 rankings.

The colleges are ranked in three categories: four-year, online and nontraditional, and two-year. Clackamas Community College ranked first in the West and fourth nationally in the two-year category.

The rankings factor in the results of Military Times' annual survey, a comprehensive school-by-school assessment of veteran and military student services and rates of academic achievement. This project evaluates the many factors that make colleges and universities a good fit for service members, military veterans and their families. More than 600 colleges took part in this year's survey.

"It's been amazing to witness how colleges all across higher education have embraced service members and their families," said Amanda Miller, editor of Military Times' Best for Vets rankings and special editions. "We award the Best for Vets designation to the very best - the colleges that really are setting the example."

Military Times' annual Best for Vets: Colleges survey asks colleges and universities to document an array of services, special rules, accommodations and financial incentives offered to students with military ties; and to describe many aspects of veteran culture on a campus. Military Times also factors in data from the Veterans Affairs and Defense Departments, as well as three Education Depart-

ment sources: the IPEDS Data Center, College Scorecard data and the Cohort Default Rate Database.

"Our veterans are an integral part of our student body here at Clackamas Community College," CCC President Joanne Truesdell said. "We have made outreach and service a college commitment in support of our military families and veterans."

CCC is proud to serve veterans with a range of services, including the VET (Veterans Education and Training) Center on the Oregon City Campus, which is staffed with full-time veteran advocates and co-located with the only Army Strong Community Center in the West.



# CCC Presented With NWAC President's Cup

Honoring the hard work of CCC's athletes, Clackamas Community College President Joanne Truesdell was presented with the 2014-15 Northwest Athletic Conference President's Cup on Nov. 10.

The President's Cup is awarded to institutions based on their athletic teams' academic performance. According to NWAC, points are awarded for student athletes who complete 36 credits, 72 credits, or complete a certificate or degree. The amount of points awarded is determined by the student athletes' GPAs.

The NWAC awards two cups each school year, a largeand a small-school division. The CCC Cougars took the large school division and Blue Mountain Community College Timberwolves took the small-school division.

"Receiving the NWAC President's Cup is a great recognition for our student athletes, our coaches and our instructors," CCC President Joanne Truesdell said.

The CCC award presentation took place at 5:40 p.m. in the lobby of Randall Hall on the Oregon City Campus. It will be presented by NWAC Executive Director Marco Azurdia. Attendees were invited to stay after the presentation to support the CCC volleyball team for its last regular season match as they hosted Linn Benton in the gym at 6 p.m.







Clackamas County contracts with three warming center providers for homeless shelter beds on nights when the weather is predicted to be 32 degrees or lower, or when other conditions such as accumulated snowfall or high winds make sleeping outdoors especially dangerous.

Homeless adults are the primary demographic that accesses these warming centers, but families with children may also access them. Each site decides by 1 p.m. whether or not they will be open based on National Weather Service predictions for their local area. Contact them directly to see if they are open on a given day. ### Oregon City Cemetery Vandalized

On November 13, 2015, at 6:00 a.m., employees arrived at the Mountain View Cemetery located at 500 Hilda Street in Oregon City, to find broken windows, burnt flowers and toppled and broken grave stones.

They believe that the suspect or suspects entered the

cemetery sometime after 5:00 p.m. on November 12, 2015, likely by jumping the fence. Employees found broken windows, broken flower vases, burned plastic flowers left by mourners, and a heavy granite war memorial bench knocked to the ground. Water spigots were kicked over, and 31 headstones were damaged in the pioneer section of the cemetery, which is the burial site of Oregon City pioneers dating back to 1847. Some of the grave stones, including several of historical significance, are irreparable.

Employees have estimated the damage to be around \$8000.00 to \$10,000.00. The Mountain View Cemetery is offering a \$500.00 reward for information leading to an arrest in this case. Anyone with information is urged to call the Oregon City Police Department tip line, at 503-496-1616. Callers may remain anonymous.

## Comments Sought on Special Access Pass Rules for Disabled Veterans

The Oregon Parks and Recreation Department (OPRD) is seeking public comment on proposed rule changes to the Special Access Pass program. This program grants veterans with a service connected disability a fee waiver for up to 10 days per month in standard campsites at Oregon State Park campgrounds.

The proposed changes will: allow these reservations to



be made on-line; simplify the stay limit to 10 days per month; add showers to the list of fee waivers available to pass holders; add a \$5 fee for replacement of a lost pass; clarify when a pass can be revoked or temporarily suspended; add penalties for failure to cancel; and impose a penalty for leaving early without letting park staff know. # Millions of Columbia River Salmon Return Home For The Holidays

The Columbia Basin's 2015 salmon season ended with a remarkable 2.3 million adult salmon passing Bonneville Dam on their up-river migration. Overall, this makes 2015 the second-strongest year for Columbia River salmon since the Federal Government built dams on the river nearly 80 years ago.

"We have a lot to be thankful for in the Columbia Basin," said Paul Lumley, executive director of the Columbia River Inter-Tribal Fish Commission. "This only highlights what we can accomplish as a region. Yes, there is more work to be done to address things like climate change, water quality and water temperatures, but this success provides the confidence to achieve full salmon recovery."

Approximately 954,000 Fall Chinook salmon made up roughly half of the 2015 run and represented the largest Fall Chinook return ever recorded on the Columbia, edging out the 2013 record.

Threatened Snake River Fall Chinook also returned in impressive numbers. Nearly 60,000 fish returned to the Snake River, the second-largest return since major dams were built on the lower Snake. In addition, approximately 20,000 wild Snake River Fall Chinook crossed Lower Granite Dam to spawn naturally upstream in the river's main stem and large tributaries.

"When you look at how well salmon did overall this year, it's clear the approach of restoring critical fish habitat and improving dam passage is working," says Lorri Bodi, vice president of Environment, Fish and Wildlife at the Bonneville Power Administration. "This is a direct example of partnerships with Northwest tribes, states, the Northwest Power and Conservation Council and the Fed-

eral Government -- working together to bring more fish back to the rivers."

Not all Northwest fish runs fared well in 2015. Several weeks of unseasonable temperatures

heated river water decimating this year's run of endangered Snake River Sockeye salmon, despite efforts to save them. Approximately 4,000 of the endangered salmon had passed Bonneville Dam on their way upstream, the most ever counted at Bonneville since Federal recovery efforts for this run began in the 1990s.


Thankfully, conservation hatcheries established to preserve and rebuild endangered Sockeye numbers served their purpose of safeguarding the genetic heritage of the species. In addition, biologists released 600 hatchery Sockeye into Idaho's Redfish and Pettit Lakes to spawn naturally. Research shows offspring of Sockeye spawned naturally in the lakes return at higher rates than those released from hatcheries.

Overall, the cumulative 2015 run of Columbia River salmon is one of the largest in almost eight decades, allowing anglers to catch approximately 600,000 fish.

"Federal agencies, tribes, states and other Northwest parties can be thankful that their collective efforts, in combination with strong ocean conditions, is supporting impressive numbers of returning salmon," said Michael Tehan, NOAA Fisheries' assistant regional administrator for the agency's Interior Columbia Basin Office. "That's something every citizen in our region can celebrate."

# Sketch Released in Hope of Identifying Redland Armed Burglary Suspects

On Saturday October 19, 2015, early afternoon, a resident interrupted a burglary in the 19000 block of SE Fishers



Mill Rd outside of Oregon City. Two burglary suspects were armed and prepared to commit a takeover type robbery. When the male resident walked in on the suspects, one of the suspects held him at gun point and used plastic ties to bind his hands and feet. ## Single Vehicle Fatal Crash on Hwy 213 - 2 Miles South of Molalla

On November 19th, 2015, at about 11:20 p.m., OSP Troopers and emergency personnel responded to the report of a motor vehicle crash on Highway 213 at milepost 18 (south of South Dart Road).

Preliminary information indicates that Gerald Wayne MARTIN, age 65, of Silverton, was operating a 1995 Nissan pickup and traveling southbound on Highway 213 near milepost 18. For unknown reasons, the Nissan veered off the roadway, traveled back on, overturned and ejected MARTIN from the vehicle. The Nissan came to rest on the northbound shoulder.

MARTIN was pronounced deceased at the scene and was not wearing a safety belt. Alcohol may have been a contributing factor and the highway was closed for over 3 hours for the investigation to be conducted (there was an established detour in place).

Oregon State Police is currently investigating the crash and was assisted by the Molalla Fire Department, Clackamas County Sheriff's Office and Oregon Department of Transportation (ODOT).

On Friday, November 27, 2015, the Clackamas County Sheriff's Posse kicked off its annual holiday-season presence on horseback patrol in the Clackamas Town Center parking lot.

This time around, they're once again joined by enhanced Sheriff's Office bicycle patrols.



This will be the 18th year the Posse has worked with the Town Center to welcome shoppers and provide a striking holiday presence -- and the Bike Patrol's second.

Last year's Posse/bike patrol initiative was a big success. "After a weekend of increased patrols, I'm happy to report there were no reported vehicle break-ins during the enhanced service time," said Sgt. Bradley O'Neil in one November 30, 2014 email. "We did not catch anyone breaking into or even attempting to break into cars. A lot of that has to do with the high visibility of the increased Town Center security, mounted posse and CCSO Bike patrol."

Another example: In December 2013, three Posse members on duty at the Town Center spotted a man wearing a surgical mask running out the door carrying stolen items. The Posse sprang into action and caught up with the suspect on their horses. They were then able to get a description of his car's license plate number and gave that information to the Sheriff's Office. The man was arrested at his home that afternoon.

The Posse encourages the public to come meet our four-legged partners during this holiday season. The Posse will stage their trucks and trailers in the south lot of the Town Center, just south of Sears.

The Sheriff's Office reminds shoppers to lock their car doors and keep valuables stowed away and out of sight while away from their vehicles.

Parking costs \$5 a day at 26 Oregon State Parks unless you have a 12 or 24 month parking permit or a same-day camping receipt. The 24-month pass is \$50. The permits are transferable from vehicle to vehicle.

"Look forward to another year of hiking, camping, beachcombing, and picnicking," says Lisa Sumption, Oregon Parks and Recreation Department director. "When you get or renew yours, consider giving one as a gift. Your friends and family will thank you."

Kamrath Road for the 2016 year.

OCCT has acquired the rights to stage "Madeline and the Gypsies" (a production based on the classic story by Ludwig Bemelmans) as their first show at the Grange. It will perform in late February.

# Hamlet Board Members Give Testimony on Beavercreek Road Concept Plan

Recently, two Hamlet of Beavercreek Board members gave testimony to the Oregon City Planning Commission regarding the multi-development projects slated for property near the Oregon City High School on Beavercreek Road.

In their presentation they pointed out the serious problems with the plan including lack of planning for transportation along Beavercreek Road and projected another Sunnyside Road scenario for the citizens of Beavercreek.

Another issue they pointed out was the problem with the plan for supplying the development with adequate water through an Intergovernmental Agreement with Clackamas River Water. The plan does not take into account that the Clackamas River is not a finite resource, which became painfully clear this last summer, when due to the drought the river was so low and water temperatures so high that the fish die-off was worse than at any time in history. If water is not used wisely and last summers weather repeats itself, development along Beavercreek Road could put the residents of Beavercreek in jeopardy.

Also, sewer issues that are already an issue in the area would be exacerbated by putting the strain of high density development on the system. This was a very informative presentation. If you would like to read it in its entirety go to

# Loan Refinancing Program For Underwater Borrowers Expands

Oregon Housing and Community Services (OHCS) and the Oregon Homeowner Stabilization Initiative (OHSI) are pleased to announce the expansion of the Loan Refinancing Assistance Pilot Project (LRAPP).

LRAPP is designed for homeowners who have suffered financial hardship and have substantial negative equity in their homes, but could afford a payment at the current value of their home. LRAPP has been operating in Crook, Deschutes, Jackson, Jefferson, and Josephine counties since 2011. These counties experienced the highest rates of negative equity and were extremely hard hit by the foreclosure crisis.

"For homeowners who continue to be underwater, meaning they owe more than their home is worth, this program can help them get back on their feet," said Margaret Van Vliet, Director of Oregon Housing and Community Services. "In some communities, more than 1 in 10 homeowners are still underwater on their mortgage. LRAPP is an innovative, one-of-a-kind refinance program to help people avoid fore-closure."

On December 2, 2015, OHSI will open LRAPP to homeowners in 17 additional counties in the eastern, central, and southern portions of Oregon including: Baker, Coos, Curry, Douglas, Gilliam, Grant, Harney, Klamath, Lake, Malheur, Morrow, Sherman, Umatilla, Union, Wallowa, Wasco, and Wheeler counties. In January and February, OHSI will open LRAPP to homeowners in additional counties. The full opening schedule can be found at: http://www.oregon.gov/ohcs/pdfs/ohsi/11192015-LRAPP-Schedule.pdf. Clackamas County is scheduled to open February 24, 2015.

OHSI anticipates opening 50 application slots every two weeks for eligible homeowners in those counties. Homeowners can take an eligibility quiz on the OHSI website here: http://www.oregonhomeownerhelp.org/en/homeowner-education-program/lrapp-program.

Homeowners who may qualify for LRAPP include: \* Homeowners with significant negative equity in their

- homes
- \* Homeowners who may be behind on their mortgage payments
- \* Homeowners who could afford their mortgage at the amount their home is currently worth
- \* Homeowners whose incomes are at or below 150 percent of the state's median income (details are included in the eligibility quiz.

All prequalified applications are subject to available funding at the time of closing or December 31, 2016 (the program close date). Participants are not guaranteed funding upon submitting an application. U.S. Treasury was expected to approve this program change on November 24, 2015.
