Storm Clean-Up Tips From Clackamas County Residents Advised Not to Burn Yard Waste or Debris

The Clackamas County Community Environment Department has tips for people still cleaning up from the early January storms.

Yard debris – Residents should **NOT** burn yard debris, instead please take it to an appropriate disposal site. Leaves, yard debris and wood disposal sites are listed below:

Sandbags – County residents who have sandbags are encouraged to keep them for the remainder of the winter in case they are needed again.

Garbage collection – According to Rick Winterhalter from the County's Community Environment Division, garbage haulers did not send out their trucks under the storm conditions because of safety concerns. Collection services resumed as soon as it was safe to do so and haulers collected accumulated waste at no extra charge. Winterhalter said it is not feasible for the haulers to offer rebates for delayed service, but there will be more focus on communicating with the public about collection schedules in similar situations in the future.

If water flooded your septic system – minimize your use of water for washing and wait for the water level to drop.

If you come in contact with standing water – wash carefully before you eat or drink.

You Might Qualify For Free E-Filing and Not Know It

If you haven't e-filed in the past because you didn't want to pay for it, or weren't sure which software to use, the Oregon Department of Revenue can help.

Many taxpayers who are still filing paper returns don't realize they may qualify for free e-filing.

Free e-filing products have restrictions that may include age or income. The restrictions change every year. If you haven't previously qualified for free e-filing, this year you might.

The maximum income for free e-filing has been increased, along with changes to age restrictions. Most tax-payers under 25 years old will qualify for free e-filing services.

"More people than ever will qualify to e-file their tax returns for free," said Revenue's e-filing coordinator Mark Ruth. "And if you don't qualify, there are a lot of other e-filing options."

Whether you can use a free e-file product or one you pay for, e-filing is an efficient and fast way to file tax returns.

E-filers enjoy these benefits:

Faster refunds—With e-file, taxpayers get refunds quicker than it takes to file a paper tax return and receive a refund check. E-filers who choose direct deposit can usually receive their refund in as little as

File now, pay later options - Taxpayers can file early and pay later by scheduling an electronic funds transfer (http://www.oregon.gov/DOR/ESERV/eft-list.shtml) any time through April 15, 2009. Taxpayers can also pay by credit or debit card (http://www.oregon.gov/DOR/ESERV/cc-payment.shtml) when they e-file their returns.

Quick electronic confirmation - E-filers are notified when their returns are received.


Convenient Federal/State e-filing - E-filers can file their federal and Oregon returns at the same time.

"Our website provides descriptions of the free e-file products, each company's restrictions, and links to the free efiling software," Ruth said.

The department's website also provides information about and links to all other Oregon-approved e-file products (http://www.oregon.gov/DOR/ESERV/online.shtml) . The cost of each of these online e-file products is listed, beginning with the least expensive at \$9.95.

"We encourage electronic filing, but we don't support or recommend any software company or product," Ruth said.

In the Midst of Sadness New Life and New Hope

For 7-month-old Jesus and his family, little Jose will forever be a hero. Jose was born one month after Jesus and suffered from a congenital heart disease. He spent his 6 months on this earth in and out of hospitals and two days before Christmas, Jose's heart decided it just couldn't fight any longer and he died. His parents, in their darkest hour, looked beyond their own pain and chose to give an amazing gift to someone they had never met.

Nearly 2000 miles away, Jesus and his family waited, hoping for a Christmas miracle. Jose became that miracle. Jesus was born with an extremely rare eye disease called sclerocornea, a congenital anomaly in which all or part of the cornea is opaque and resembles the white of the eye. In Jesus' case one eye had completely clouded over and the other eye was progressing to that point rapidly. Because of the need to transplant similar tissue to be successful, only another infant's corneas would do.

Lions Eye Bank of Oregon received a call on the morning of December 23rd notifying them of little Jose's death and his parent's desire to help someone else in need. Timing was crucial with this case because Christmas was just two days away and Oregon was in the midst of an Arctic storm that left limited flight schedules available. The tissue was recovered and once it was determined to be eligible for transplant left for its final destination on Christmas day. Two days later the surgeon in Mexico transplanted little Jose's gift to Jesus.

The next day the Lions Eye Bank of Oregon received this message from the transplanting surgeon:

Jesus' family send their deepest sympathy to the donor family and say this was a true miracle of Christmas. Though the pain of losing a baby can never be compared to anything, the joy of receiving the Gift of Sight for their baby Jesus has forever become the reward for both families. In the midst of sadness and a short life ending, there is happiness for the start of a new life and new hope!

On December 31st, with heavy hearts that continue to heal, Jose's family honored the short life of their beloved son with a memorial service. The service was not one solely of grief, but instead one of hope and celebration of a life that helped give new life to another. While it would be easy to be consumed by grief at the loss of a child, Jose's parents didn't hesitate when given the opportunity to help another. Jose's mother says that knowing little Jesus will be able to see because of Jose's gift has helped ease some of her pain and has inspired her to want to encourage others to donate.

"It was such a pleasure to be involved with this special story", said Jameson Clover, Eligibility Specialist for the Lions Eye Bank of Oregon. "To know what a difficult time this must be for Jose's parents and to know they were able to look beyond their own grief to give hope to Jesus and his family was really such an amazing Christmas present."

The Lions Eye Bank of Oregon is a non-profit organization founded in 1975 to serve Oregon and Clark County, Washington by providing recovery of ocular tissue for transplants, research and medical education. Since its inception, over



17,000 people have received the gift of sight from tissue procured and screened by the Lions Eye Bank of Oregon. Many more ocular tissues have been provided for invaluable research and medical education. For more information, please go to http://eyebank.orlions.org

Salem Police Warn of Compromised Oregon Territory Federal Credit Union Debit Accounts

The Salem Police Department has received over ten reports since January 12th of Oregon Territory Federal Credit Union Debit Accounts being compromised and either used or attempted to be used at various locations throughout the area.

At this time it is unknown if the suspect(s) are in possession of actual debit cards and/or account numbers, or how the accounts became compromised. The Credit Union has been contacted and is working to address the situation.

The Salem Police Department urges merchants to be extra vigilant in verifying account validity and identification of anybody attempting to use one of these debit accounts. Any Oregon Territory Federal Credit Union account holders who have questions about their account should contact the credit union.

Clackamas County Falls Short of Disaster Relief Threshold for January Storm Still Assessing Damage From **December Snow**

Clackamas County sustained more than \$2.6 million in

damage to its public infrastructure as a result of the rain and flooding on Jan 1 and 2, according to estimates compiled by the Department of Emergency Management.

The damage estimates fell well short of the approximately \$4.5 million threshold set by the Federal Emergency Management Agency for the state of Oregon to qualify for federal disaster assistance. The County sustained a considerable amount of damage and FEMA assistance may have become available had there been a request for disaster relief by other Counties.

Because Clackamas County was the only County in Oregon to request federal disaster relief, the much higher threshold for damage, needed to qualify, was not met.

The County received online damage assessments from approximately 150 individuals and about 35 businesses.

County officials are aggressively pursuing other options to help residents and businesses deal with uninsured damage. These include the possibility of low interest loans from the Small Business Administration and possibly other sources. This process is ongoing and could take months to complete.

bers with three proposals for reducing expenditures in next year's budget in order to address a more than \$6 million budget shortfall. The district's shortfall stems from declining enrollment trends, recently announced reductions in State funding, and increasing personnel and energy costs.

The three proposals Superintendent Rada presented to the school board are outlined below:

Traditional Reductions: Cuts district-wide including more than 60 Licensed staff, 25 Classified positions and eliminating all elementary PE and music. Middle school and high school sports would also be significantly affected.

Restructuring & Reductions: Would include closing Park Place Elementary.

Four-day school week: Implement a four-day-school week. This entails adding about an hour to each instructional day. Savings are found in transportation, reduced energy



consumption, and in reduced work hours for some classified staff.

The district began to feel the financial pinch last year when it made reductions to its budget and used one-time sources of revenue that together added up to a nearly \$2.2 million impact on its budget. The district is out of one-time revenues and needs to make reductions of nearly \$6 million in next year's budget in order to get ahead of the financial downturn.

The district's budget committee will begin meeting this month with public information and input sessions slated for February. The School Board typically adopts the final budget in May.

Storm-ravaged Clackamas County Property Owners May Qualify for Property Tax Relief

Clackamas County property owners that sustained damage caused by flooding or landslides from the storm in early January may be eligible for property tax relief through an "Act of God" provision.

The provision, available to all statewide property owners, allows for a reduction in taxes based on the scope of damage and the date the damage or loss occurred.

An "Act of God" is generally considered an act attributable to nature without human interference. For example, damage caused by flooding or landslides would qualify. Residents who sustained property damage may receive a proration of

their property taxes.

Also, property owners can opt to have their property reassessed. Here is how it works. Oregon's property tax year runs from July 1 through June 30 of the following year. All property is valued as of Jan. 1 each year. If your property was damaged or destroyed through an "Act of God" between Jan 1 and July 1, you may also elect to have the property's market value and assessed value re-determined as of July 1.

Applications are required to qualify for either the proration of taxes and/or reassessment as of July 1. The filing deadline for tax proration is no later than the end of the tax year in which the destruction occurred or 60 days after the date the property was damaged or destroyed, whichever is later.

The deadline for reassessment is 60 days after the damage or destruction of Aug. 1 whichever is later.





Clackamas County Recorder Will Soon Host Friday Hours

The Clackamas County Board of Commissioners approved an alternate workweek for more than 1,200 employ-



ees last October, allowing County offices to be open longer for public business while reducing energy costs and the County's carbon footprint.

In the past couple of weeks, the Board of County Commissioners approved several changes in the County Recorder's office to better serve the public and maintain the efficiency of the alternative work week.

Those changes include opening the County Recorder's office from 10:00 a.m. to 3:00 p.m. on Fridays to allow for the recording of real estate transactions five days a week. The Recorder's office had been closed Fridays in keeping with the alternate workweek.

The new schedule may not take effect for several weeks. The changes follow a series of meetings and discussions with representatives of the local real estate community, title agencies and financial industries to discuss the impact of the alternate workweek on their service delivery efforts.

"As our Alternative Workweek Pilot Program has evolved we have recognized the need to make accommodations to meet the important needs of our citizens and our business community, said County Commission Chair Lynn Peterson. "This is one of those occasions."

Other changes being contemplated are driven by economic considerations. There has been a steep decline in recording fees over the past year. In fiscal year 2008, Clackamas County averaged approximately \$225,000 a month. In fiscal year 2009, the County is projected to average \$148,000 in monthly revenue based on an annualized calculation.

State ATV Grants Committee Seeks New Member

The Oregon Parks and Recreation Department (OPRD) is seeking a volunteer to represent dirt bike (Class III off-highway vehicle) riders on its All-Terrain Vehicle (ATV) Account Allocation Committee.

The committee, which has seven voting members appointed by the Oregon Parks and Recreation Commission, advises OPRD on the dispersal of State ATV grants. Government agencies and non-profit organizations use the grants to develop, maintain and acquire ATV riding areas; for safety education and training; and to provide law enforcement. ATV permit sales and a percentage of the unrefunded fuel tax revenue fund the grants.

Vets May Receive Free Tax Help With Online Service

Free tax help and filing services to military service members and their families during tax season are available through an online service, according to the Clackamas County Veterans Services Office in Oregon City.

Users must register for Military OneSource at www. militaryonesource.com and log on to the site for access to the online TaxCut program.

Those eligible are active duty, National Guard and Reserve (regardless of activation status), spouses and dependent children, family members handling the affairs of a deployed service member, Department of Defense employees working in support roles and severely injured service members or family members handling their affairs.

Participants will have free access to the H&R Block Basic TaxCut program. Those with more complicated returns may incur charges if they upgrade to the H&R Block TaxCut Premium program . Participants may e-file one state resident return for each federal return that they e-file with TaxCut Online. Find out more about the program by visiting the Military OneSource Tax page and see the frequently asked questions or FAQs.

State Pursues Dishonest Businesses

Earlier this month a Beaverton man pled guilty to racketeering in a case that involved charges of tax evasion. His conviction carries a five-year sentence without the chance for parole.

Maurilio Castillo Vega was involved in a scheme to avoid paying income and payroll taxes and Workers' Compensation and unemployment insurance. Vega paid workers in cash under the table. He didn't withhold taxes from employee pay or pay payroll taxes. The scheme allowed Vega to underbid legitimate competitors.

The Oregon Department of Revenue encourages businesses to file and pay taxes correctly, and issues a warning to those that don't.

Revenue is part of a network of State agencies on the lookout for dishonest business people like Vega. Employees from the Department of Revenue, Employment Department, and the Department of Consumer and Business Services visit worksites to educate employers about their duty to pay payroll taxes and to check for compliance.

The network's goal is to provide a level playing field for honest Oregon businesses.

"We will continue our educational outreach to businesses about filing requirements," said Larry Warren, Business Collection Services Manager. "We will also continue to enforce the law when businesses don't file and pay appropriately."



Clackamas County Commissioners Conclude Interviews For County Commission Vacancy

Clackamas County Commissioners have completed their interviews for the open commis-



sion seat and were expected to make an appointment by January 29, 2009.

Five candidates interviewed Tuesday evening, January 27, 2009, for the vacancy created earlier this month when Commissioner Martha Schrader was appointed to the Oregon Senate.

Those interviewed were:

Sonya Fischer, a Lake Oswego attorney, whose practice focuses on family special education and juvenile law.

Judie Hammerstad, a former Lake Oswego mayor who has served as a Clackamas County Commissioner and a state legislator.

Ann Lininger, a Lake Oswego attorney, and director of program-related investing for the Meyer Memorial Trust.

Linda Moraga, a director of the North Clackamas School District.

Carol Sturman, chair of the Oregon City School board.

The candidates were interviewed Tuesday during a public hearing. Each candidate answered a round of questions put to them by County Commissioners on a variety of topics ranging from revenue challenges during an economic downturn to funding cuts for human services and social services.

The commissioners are choosing among 126 applicants for two open commission seats. That includes 23 applicants for the existing vacancy and the pool of applicants for a previous vacancy filled earlier this month by former Estacada mayor Bob Austin.

Commissioner Austin filled a vacancy that was created when the County Commission expanded from three to five members and Lynn Peterson became the first popularly-elected Commission Chair.

Commissioners Jim Bernard and Charlotte Lehan were elected to the expanded board in November.

Filling Seats on The Board of Clackamas County Commissioners

If I'm right it will be very unfortunate for the residents of Clackamas County who live in rural areas when the Board of County Commissioners make their decision and fill the remaining vacancy on the Board. It appears the Board will be made up of individuals whose expertise and previous positions have been from City, County or State Governments, or people with no apparent experience other than living in Lake Oswego, the home of Chair Lynn Peterson.

There apparently will not be one individual on the Board that will represent the residents of the County who live in rural areas. An oversight that can only lead one to believe that the rural residents of Clackamas County are not considered worthy enough to have a representative on the Board.

After all the time and money spent on the Complete Community project, that showed the rural areas wanted a voice, wanted to be proactive and represented with a seat at the table, it is indeed unfortunate that the Board could not find it in its power to reach out to ALL their constituents

The Board will be instrumental in the decisions that will take place in December of this year with regards to the Urban and Rural Reserves and which lands will be designated for the next 50 years for possible urban expansion. This process will have profound consequences to the rural residents of Clackamas County. Not just those who live anywhere near the current urban Growth Boundary, but beyond.

"No voice or seat at the table" is another example of business as usual. Five Commissioners now, instead of the three Clackamas County had for so long, apparently will not make sure that ALL people in Clackamas County will be represented. What this will mean for Beavercreek and other rural areas is in question.

With the Board made up of urbanites, which in my humble opinion do not respect the opinions and expertise of their rural constituents, we are all in trouble.

Government of cities/by cities have proven time and time again that they are like the voracious beast. The beast requires to be constantly fed by any means, including gobbling up everything around it, with no concern for those consumed. Except... for the tax dollars they add to the pie.

I believe that the Board of Clackamas County Commissioners has done a great disservice to approximately half of the residents of our County.

The residents of Clackamas County voted to expand the County Commission to five believing it would be better for

the County and resolve some governance issues. This was done at considerable expense to the taxpayers.

I believe we were duped. It will only entrench the urban mentality further. This is a sad time for the rural residents of our great County.

I for one am disheartened with the whole process. The credibility of the whole process is in question in my mind. Politics as usual... what a shame. The Editor.



The January meeting of the Hamlet of Beavercreek took place on Wednesday, January 28, 2009, at the Beavercreek Grange on Kamrath Road at 7:00 p.m. with 33 residents and guests attending.

There was no guest speaker.

There was only one land-use matter before those present. It was an Alteration Change of Non-Conforming Use for the property on Hwy 213, formerly the log furniture store. The applicant wished to run a pet day-care facility. The motion passed.

One of the members wanted to know if anyone else was having problems with BCT's cable/internet/telephone service. Discussion followed. Apparently, several who were present are having numerous problems with BCT's services. It was suggested to document issues and share them at BCT's annual meeting.

Larry Church reported on the activity on the property across from the Beavercreek Saloon and Restaurant. The County required, when the new subdivision at that location was platted, that they needed to widen the street 6 feet. There will also be a sidewalk and planting area. Larry was interested in the possibilities for the front lot that included the old barn. Anyone else interested, contact Larry Church.

A document was also passed out that contained the results from the survey that was done by the Hamlet. Larry Church is working on a program to utilize this information for the Hamlet's use.

Norm gave an update on the Urban/Rural Reserve PAC meeting. Apparently, they are looking at land as far south as Spangler Road in the studies. Maps were passed out and the ramifications of the study discussed.

Christine Kozinski gave a report on the emotional meeting she attended regarding the proposed closure of Park Place Elementary School, that has 200 students, by the School District.

The school needs \$600,000 to fund the school. Over 100 concerned parents and residents attended. If the school closes the students would have to be bussed to the closest school that would have room for them. This would cause an increase in the cost for bussing including fuels costs. Christine suggested opening a dialog between the School District and the community to try to solve the problems. Christine shared that when a school like Park Place closes the nucleus of the community is lost. A request was made to have

someone from the school district come to talk to the Hamlet.

Judy Andreen reported on the filling of the seats on the Board of Clackamas County Commissioners. She said that it was very likely that another City based person would be chosen. She said that the Hamlet Board had written a letter to the Commission asking that a rural based person be selected. If not, 47% of the County's rural residents would not be properly represented.

Everyone is encouraged to attend the monthly Hamlet Community meetings and the quarterly Town Hall meetings to participate and share ideas and concerns on the issues pertinent to our community. Members 18 years of age and older who live, own a business, or property within the Hamlet area may vote on Hamlet issues. The Community meetings take place on the fourth Wednesday of the month at the Beavercreek Grange on Kamrath Rd at 7:00 p.m. The Town Hall Meetings will occur every quarter.
