Bulletin Advertiser Robbed

One of the Beaver Creek Bulletin's long time advertisers, Dee-J's Harvest Moon of Mulino, was robbed in the early morning hours of Sunday, June 15th.

Two men and a woman in a white moving van with a white lift pulled onto the store property on Friday during business hours. One of the men and the woman got out and asked Dee Hamilton, the owner, a lot of questions regarding prices, etc. The other man remained in the truck. Dee had an unsettling feeling about the incident and tried to get the license number when they left.

On Saturday, Dee closed the store at about 7:00 p.m. and went home. At about 10:00 p.m. Dee received a call from Roger Engle, the owner of The Mulino House Bed and Breakfast, next door to the market.

Mr Engle was sitting in the parlor with two guests when the van pulled in. Mr. Engle saw a woman jump out of the van and try the gate. The van then went onto his property. He looked at his guest and said "That didn't look right." He then called Dee to see if she was expecting anyone. She wasn't. Dee hurried back to the store and with the help of Mr. Engle brought in a number of bird baths, bird feeders and other outdoor accessories. They took in everything that they could carry. Dee then turned on all the lights and turned on the "open" sign and stayed at the store until midnight.

Dee also called the Clackamas County Sheriff's office and requested that the patrol officers watch the store.

On opening the store the next morning at 7:00 a.m. she noticed several items were missing. The burglars apparently tried to break into the store, but then opted to seize items from the outdoor shopping area.

The moving van was the size of a Ryder or U-Haul truck with a lift gate.

Work by the Art Department Chairman of CCC David Andersen has been selected from hundreds of entries for inclusion in the Oregon Biennial at the Portland Art Museum. The exhibition features the work of 26 established and emerging artists living and working in the state of Oregon.

The Oregon Biennial began in 1949. For this year's exhibit, the museum received an unprecedented response from regional artists with a total of 927 submissions. The 2003 exhibition is the second Biennial to be juried by the museum's chief curator, Bruce Guenther.

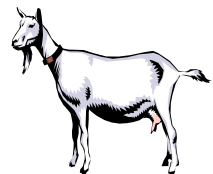

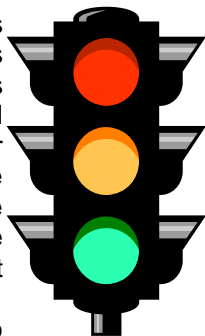

Right Turns On To Hwy 213 On Red Allowed

Well it happened again this morning. It happens more mornings than I'd care to remember, but this morning I thought... maybe I should write about this annoying behavior and get it off my chest, and in the course of doing so, enlighten those who are apparently unaware of the rules of the road. Perhaps it might help a lot of us out! So here goes.

How many times have you tried to get onto Hwy 213 going towards I-205 from Beavercreek Road only to sit there and have the traffic back up past Maple Lane in front of Berry Hill Shopping Center because the other drivers in the lane do NOT make their right hand turn after stopping at the red light at the Hwy 213 intersection? They just sit there and wait for all the traffic coming from the direction of Molalla Avenue to make their turn onto Hwy 213. I know that part of the problem is because they are afraid to pull out into the nearest lane



because the traffic coming from Molalla Avenue has a terrible habit of swinging out wide and entering the farthest lane from them. This is illegal. They are to pull into the lane closest to them. This then allows the Beavercreek Road people coming from Beavercreek the opportunity to use their closest lane to enter Hwy 213.

If these drivers would take their right turn after stopping at the red light then the rest of us wouldn't have to sit and wait until all of this traffic gets onto Hwy 213 only to then have the signal on Hwy 213 turn green and then have to sit there and wait for all that traffic to go by before we on Beavercreek Road can go anywhere.

I just make sure the the car coming from Molalla Avenue is paying attention to what they are doing and that they see me. I then pull into the proper lane and I'm finally on my way. Hopefully the car behind me was paying attention and does the same thing. The traffic would move through the intersection at a much faster pace if everyone would follow this simple rule so we can all get where we are going in a timely manner. The Editor

"Beavercreek Oregon a History Through the Looking Glass"

- - - THE POSTAL SERVICE - - -

In the early days people had to travel to Oregon City to get their mail, and if the weather was bad or they were otherwise unable to get to town for two or three weeks, they went that long without any mail.

The history of the Postal Service is very complex, interwoven over the years with such names as BEAVER, RINGO POINT, MINK, CARUS, CLARKES, HIGHLAND, SCHUBEL, BEAVER CREEK, HOFF, and finally BEAVERCREEK. These names will be used in the order in which they were established, which provides some surprises being somewhat different from what has been generally accepted.

The following information came from examining a microfilm on Oregon Post Offices obtained from the National Archives and Records in Washington, D.C. The earliest established Post Office was named Beaver, Oregon. The exact location was not shown; but it is known to have been in the Carus area and was established on December 2, 1868, with Mr. James K. Graham serving as Postmaster. Mr. Graham was succeeded by Mr. Joseph A. Wright on July 23, 1871, who served until the office was discontinued on September 19, 1871. The Office was again re-established on January 4, 1875 when Mr. Christian T. Vonderahe became Postmaster and was succeeded by Mrs. Catherine Jones, who served until the Office was discontinued February 21, 1883. It appears that Beaver, Oregon would not die easily because we find evidence that it was again re-established at an

unknown date, with a Mr. Andrew A. Stubbs serving as Postmaster until again discontinued. The film on this item was not so clear as the rest and we prefer to leave out the dates we believe to be incorrect, rather than to include wrong information.

Another Post Office was established on May 16, 1876 and named Ringo Point, Oregon, with Mr. William J. Allison appointed Postmaster. He served through September 6, 1877 when Mr. Daniel Yarwood received the appointment serving through June 3, 1878, when Mr. Iven Stevens assumed the position and served until April 3, 1879, when the Post Office was closed.

On February 1, 1886, the Mink, Oregon, Post Office was established; and according to electrostats from the National Archives and Records, was located at the northeast corner of the intersection of South Beaver Creek Road and South Carus Road. The first Postmaster was Mr. George H. McPherson and was succeeded by Mr. Charles Moehnke on June 15, 1887.

At an earlier date it was shown that a Mr. Edward Hughes had received the appointment as of May 21 that same year, but the order was rescinded as of June 15, 1887, the time of Mr. Moehnke's appointment. This Office was in the farm home of Mr. Moehnke, which also served as a store. The Office was discontinued on May 25, 1894.

A Post Office named Carus, Oregon was established on June 7, 1887 when a Mr. David Hunter was named Postmaster and served until Carrie H. May was named to succeed him on November 28 of the same year, and in turn was succeeded by Hattie A. Hunter, whose appointment was dated December 7, 1888. Hattie

Hunter served until April 2, 1891 when Mr. Robert M. Cooper took over and served in that capacity until the office was closed on July 27, 1907.

Clarks, Oregon was established May 13, 1889 when Mr. Irvin L. Clarke became Postmaster and served until August 18, 1894. Mr. George W. Grace was named to the post on June 24, 1895, serving only until July 20 of that year when Mr. Henry Kleinsmith took the helm, serving until the Office was closed on January 14, 1905 when the mail service was changed to Oregon City.

Highland, Oregon was established on March 20, 1890, with Luceine Stout appointed Postmaster and was followed by a rapid success of Postmasters:

Mr. Eugene Kirk served October 10, 1881 to February 3, 1892, Emma I. Candle to December 6, 1892
Godfried Wallace (Date unclear)
Peter A. Fairclough to November 25, 1895
Charles D. Kirk to May 7, 1897
Lois Rath to June 22, 1899
William C. Buckner to January 26, 1903
George A. Patterson to February 13, 1904
T. J. Wirtz to October 29, 1904

On this date, October 29, 1904, the Office was officially closed with service transferred to Oregon City, and with the rash of Postmasters, one can only conclude that the position was neither a prestigious nor a lucrative one.

Schuebel, Oregon was established on December 6, 1891 when Mr. Gustav Schuebel was appointed Postmaster and served in that capacity until the Office was discontinued on March 15, 1906.

Beaver Creek Telephone **Annual Meeting Held June 14th**

The Annual Meeting of the Members of Beaver Creek Cooperative Telephone Company was held on Saturday, June 14, 2003, at the Randall Gymnasium on the Clackamas Community College campus.

The doors opened at 9:30 a.m. with the registration of

those attending and Members going from table to table getting information on the products and services that the Cooperative provides. At 10:30 a.m. the meeting was called to order by the Chairman of the Board, Arthur Keller.

Tom Linstrom, CEO/President of BCT, gave an informational presentation regarding the state of the company. Mr. Linstrom informed the members that there is not to be an increase in prices this year even though the costs to BCT have increased by 6% in the past year.

Mr. Linstrom also shared the following information with those present. The company is valued at about 50 - 60 million dollars with hard assets of approximately 30 million dollars. The company's debt at this time is running at about 50% of assets. He also discussed the costs to the co-operative for the EAS (Extended Area Service) that the Co-op provides to the members. This includes all calls outside the "632" and "518" exchanges. For the year 2002 the cost for EAS to Portland and other areas outside our exchange was about \$2,600,000.00.

It cost approximately \$659,891.00 for local calls

within the exchange and \$649,000.00 for in-state long distance with out of state long distance calls costing \$2,157,858.00.

The internet service had a total 28 million minutes of use with 889,000 connections for the year. At this time BCT currently has approximately 5,000 customers and growing.

Mr Linstrom noted that BCT has been rated in the top 3 of co-ops within the state.

It was also noted that the company lost approximately \$67,000.00 in revenue due to the bankruptcy of MCI.

One of the new services that BCT is going to be looking at and possibly offering is Prepaid Calling Cards. It was explained that collect calls are not allowed unless you call the business office and request the feature to be turned on. This is due to the high costs and fraud incurred making collect calls. The prepaid calling cards would be a great help when you need to call home when you are away because

you will pay far less for the minutes and you won't have to make a collect call.

It is planned to put in an Internet Cafe site at the Henrici office and possibly one at the Spangler Road location for the customers at the south end of the exchange. There is also a possibility of putting one in Haggens for the Oregon City customers and another one in at Pettersons on Beavercreek Road in Clarkes.

Also planned for September/October is the continuation of the computer classes offered at BCT. This has not been done since BCT first became an Internet provider and will be a welcome addition for those who are new to computers.

A survey was also done to find out about interest in BCT becoming a cell phone provider. Members were encouraged to fill out a survey to give input to BCT on what services, prices, features that they would be interested in.

There was also discussion on the cost of Pay Per View (PPV) movies. These are currently priced at \$3.99. A member asked if the cost could be dropped as the PPV items were originally offered for \$2.99. It was explained by Mr. Linstrom that PPV was what they call as "loss leader." It is a service that is still extended to members even though the service does not make a profit. In fact it costs the co-op money. BCT has no control over the costs

as it is set by the networks that broadcast the signal. BCT raised the cost to \$3.99 in order to try to offset the losses incurred by providing the service.

A member asked when online billing would be available? Mr. Linstrom explained that BCT has just signed a contract with The Martin Group for online billing/payment services. This will give members much more flexibility in how they pay for the services that the co-op provides.

It was also

announced that members who had signed up for Digital CATV at the meeting today would be able to sign up for three months of Digital Cable for free to test out the service. I have been avoiding Digital Cable and all the extra channels because of the added cost and there is enough TV watching that goes on at my house, but I have to say I couldn't resist. Now I'm just hoping that I don't like it at the end of the 90 days. My husband will be especially happy with the fact that the TV guide is interactive and that he won't have to sit there and wait for all the channels to scroll by to see what is on for only the next hour and a half or so. Now he'll be able to find out at what time any channel items of interest will be showing a week in advance. Oh heaven help me!

It was also announced that there was "script" available to members present at the meeting for a

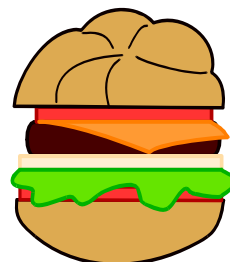

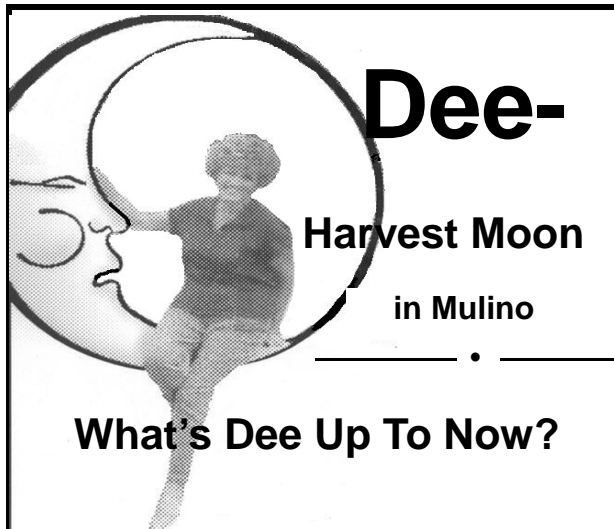

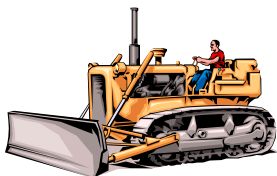

There is a program on KEX 1190 AM that runs from 6:00 p.m. to 9:00 p.m. weekdays, on Sundays from 3:00 p.m. to 7:00 p.m., and on KTLK 620 AM from 5:00 p.m. to 8:00 p.m. on Sundays. The program is called "Tom Martino The Troubleshooter".

Tom Martino is a consumer advocate that solves consumer problems, answers questions and takes complaints.

Tom Martino has had a pet peave for a long time... Unsolicited faxes! He has decided to declare war on these people. He has learned from experience the difficulties in tracking these guys down and getting them to de cease and desist!

So... www.faxwars.com was born. The idea behind it is that you go online and download a PDF file that is an assignment form. You agree to send Mr. Martino's organization your unsolicited faxes. You assign your faxes and collection rights to the Consumer Crusade. They will pay you \$25.00 for each fax on which collection is made at no cost to you. All claims, demands, suits and legal action will be brought in their name not yours. This is a lot less than the \$500.00 you could get by doing it yourself, but would you? This way his organization pays the lawyers and the fees to go to court to get the judgement. You get paid more than you would have gotten if you didn't pursue it at all and it will put them out of business.

You can go to the website and find out for yourself. It might be a very profitable exercise. The Editor

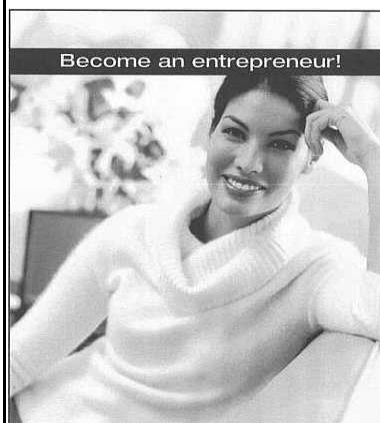

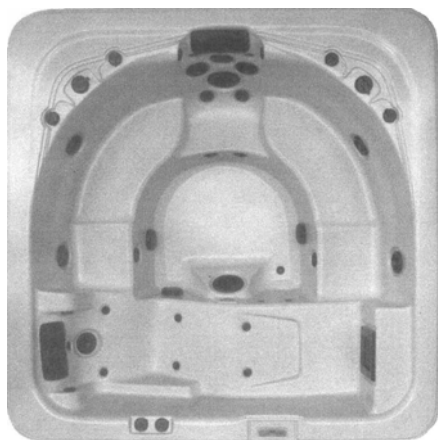
