## BCT and Canby Telcom Form Unique Management Structure First in the West - Only Second in Nation

BCT (Beaver Creek Cooperative Telephone Company) and Canby Telcom have joined together to share executive management services. Mr. Paul Hauer who has served as President of BCT for the past five years, will become President of both companies, including Canby Telcom's subsidiary Mt. Angel Telephone Company on August 1, 2013. This shared structure will take form as Mr. Keith Galitz, Canby Telcom's current President for almost ten years has announced his retirement effective August 15, 2013. Mr. Hauer has already been working with Canby Telcom and Mt. Angel Telephone Company over the past two years as their interim Chief Financial Officer, while maintaining his duties as President of BCT. Mr. Hauer is currently President/Manager of Consolidated Business Services LLC (CBS), a joint venture between BCT, Canby Telcom and Stayton Cooperative Telephone Company (SCTC), which formed in September 2012. This joint structure has been in planning for over a year and it continues the concept of cooperative sharing of resources (Accounting and Human Resources) among each of the companies for the greater benefit of each company's cooperative members.

"The telecommunications industry is undergoing rapid change and small, independent, cooperative telephone companies are struggling to survive. Customers are abandoning land-lines for mobile, and the once lucrative Cable TV market is becoming increasingly fragmented. In addition, the Federal Communications Commission is altering the rates and methods by which companies are reimbursed for services," said Mr. Hauer. "This new structure, similar to an organization that serves multiple companies in Kentucky, Tennessee and Alabama, will save both companies money while preparing for the ongoing changes in the regulatory environment and market."

BCT and Canby Telcom will contract with CBS for Mr. Hauer's services as President of both companies. SCTC will not use executive management services as Don Lawrence will continue to serve as President. As part of the new joint structure, each company will continue to maintain its own identity and position within its community, but will leverage the services of CBS employees for greater economies of scale while reducing the overall operating

## District Will Expand Educational Focus On Two Properties

See. Touch. Do. These are key steps in helping people learn about how and why conservation benefits people and places. The Clackamas County Soil and Water Conservation District is acquiring two properties to help us deliver conservation education by example.

In Oregon City, the District has purchased a one-acre parcel that is readily visible from Molalla Avenue. We will be surveying the property lines in June, and then we'll demolish old structures and recycle everything we can. We treated invasive blackberry vines last year, and we'll follow up with more management of invasive species this year.

In Beavercreek, we are purchasing a 15-acre farm. This historic property is easily accessed, highly visible, and hosts a range of natural resource opportunities. The open space it presents is valued in the community and we plan to keep much of it a working farm.

Our two properties will help people understand how conserving natural resources can work on their home place.

Seeing a conservation plan on paper does not reach people the same way as seeing those practices written on the land. Providing hands-on learning opportunities is part of our strategy to help people conserve our precious soil, water, and wildlife in a familiar setting: at home, and on the farm.



Our timeline is slow and methodical. We've completed these property purchases openly and transparently over the course of a year. We know it takes time to do this right, so we've renewed our office lease for another five

years while we work with thoughtful intention to improve these two properties to become primary teaching tools.

We'll be writing our conservation actions on the land for several years, and we look forward to hearing your ideas.

*Editor's Note:* The Beavercreek property mentioned above is located at 22055 S. Beavercreek Road. This is the Skou residence which is just before you get to Ferguson Road on the right. The property has the pond out front.

## Child Falls Into Crawl Space in Oregon City

On June 17, 2013, shortly before 6:00 p.m. a three year old girl fell 5 - 6 feet into a crawl space of a home at 14832 Meyers Rd in Oregon City. It was reported that the little girl was playing under the stairs, near the crawl space hatch with her brother at the time of the fall. The child's mother was viewing the home with their realtor when the incident occurred.

Clackamas Fire crews were able to easily make access to the patient and take necessary precautions to immobilize her and quickly remove her from the crawl space. The patient was briefly treated on scene before being transferred to Life Flight and transported to Doernbecher Children's Hospital. The child is currently in critical condition yet improving.

It is important to remember and Clackamas Fire would like to remind people, that while a five to six foot fall may

## Clackamas County Temporarily Close South Holly Lane

South Holly Lane, which runs from Redland Road to Maplelane Road, was scheduled to be closed to through traffic for 24 hours a day from 7:00 a.m. on Tuesday, June 18, through 6:00 p.m. Friday, June 21. The actual work zone

closure will be from Redland Road to Donovan Road.

The closure was needed so work crews could replace the bridge impact panels and re-pave the roadway over the bridge.

DSB is located at 150 Beavercreek Road in Oregon City. The public services lobbies offer assistance with building codes, code enforcement, development review, land use planning, zoning, soils and grading, on-site wastewater systems, sanitary sewer and surface water management, engineering, surveys and related issues.



## Clackamas County Approves Moving Forward on Trolley Trail Land Swap with TriMet

The Clackamas County Board of Commissioners, sitting as the Board of Directors of the North Clackamas Parks and Recreation District, on Thursday, June 6, unanimously approved a resolution authorizing the North Clackamas Parks and Recreation District to sell a portion of the "Trolley Trail" property to TriMet in exchange for adjacent property, subject to TriMet's ownership of the land. TriMet has not yet acquired all the property necessary to complete its portion of the transaction.

The resolution follows two questions on the May 21 ballot relating to the future of the Portland-Milwaukie Light Rail project:

Clackamas County voters rejected Measure 3-424, which asked: *Should Clackamas County use certain County resources to meet previous contractual commitments toward the Portland Milwaukie Light Rail Project?*

Voters in the North Clackamas Parks and Recreation District (NCPRD) approved the following advisory question by a vote of 9,516 in favor and 7,744 opposed:

*Should the NCPRD (North Clackamas Parks and Recreation District) sell a portion of the "Trolley Trail" property to TriMet, where TriMet would:*

- *Sell a strip of adjacent property to NCPRD for the trail;*
- *Construct that section of the trail without cost to NCPRD; and*
- *Provide NCPRD with additional compensation to make up the difference in value.*

Commission Chair John Ludlow said: "We want to get this thing going and get our trail back together, but as stated in our resolution, until TriMet is capable of performing and conveying clear title to the subject property, the deal will not be consummated."

Commissioner Jim Bernard said: "The District Advisory Board is very interested in moving forward on this as rapidly as possible."

Commissioner Paul Savas said: "My interest is getting the "Trolley Trail" property in our possession — that needs to be the focus. I'd like to see this get under way as expeditiously as possible."

Commissioner Martha Schrader said: "The County has made every effort to meet our legal agreements and regional commitments with our public and partners. The sooner we move forward, the sooner the "Trolley Trail" will be completed for the benefit of all."

Commissioner Tootie Smith, referring to the Board's public outreach, said: "I don't see how we could have reached out to the public any more than we did when we asked them to vote on light rail. We've tried very hard to

The Clackamas County Board of Commissioners held their first public hearing Thursday, June 20th to consider amendments to the County code to regulate outdoor mass gatherings and limited gatherings.

The hearing was held as part of the 6:00 p.m. Board of Commissioners meeting in the County Public Services Building, 2051 Kaen Rd., Oregon City, in room 409.

The amendments are designed to comply with State law for gatherings numbering more than 3,000 people (mass gatherings) and to add guidelines for gatherings of more

than 300 people (limited gatherings).



cacy Unit.

Gov. John Kitzhaber signed House Bill 2107 into law on May 14, 2013, and it took effect immediately.

"People can still choose the traditional paper card to show they have the minimum coverage required by law or they can present proof on a cellphone or other mobile device," Fredrickson said.

Drivers must arrange with their insurance company to receive their proof-of-coverage information in an electronic format. And, using a mobile device to prove coverage does not allow police officers to search the device for any additional information.

Whether paper or electronic, motorists still must keep proof of current and valid insurance in the vehicle. So, someone who chooses the electronic format must keep the phone charged. Failure to carry proof of insurance is a

Clackamas County in which adult mosquitoes will be trapped and identified.

Each week during the season, specific zones will be selected on an alternating basis to live trap mosquitoes. The mosquitoes will be identified and the information will be entered into a database and plotted on the zone maps. The vector species will be tested by CVCVD to determine if they carry West Nile virus. If a positive test occurs, the OSU Lab will be sent the sample for confirmation of West Nile virus.

Once a positive occurs, the CDC and CVCVD will send notification to the partners and a news release will be generated. CVCVD will continue to keep its partners in-



formed each week concerning the presence of vector species.

This year CCVCD will also be testing Jays and Crows (birds that belong to the Corvid family), Robins and Raptors for West Nile virus. Please call CCVCD at 503-655-8394 if you see one of these birds that has not been dead any longer than 24 hours and shows no obvious injury. We do not test birds that have been dead longer than 24 hours. We will start the bird testing the second week of July.

**Reminder:** Mosquitoes are hungry – protect yourself with a product con-

taining DEET. With a prediction of 80 plus degree weather for the next several days the mosquito population will increase rapidly. Don't do outside activities without protecting yourself from mosquitoes.

**Tip of the Week:**

Planning a get-together or going camping for July 4th? Protect your family and friends from mosquitoes by placing a couple of oscillating fans at the fringes of your meeting area. The wind movement will be too strong for the mosquitoes to fly against, and they will stay out of the immediate area.



## Record Number of Participants at CCC Graduation Ceremonies

More than 420 students participated in two graduation ceremonies at Clackamas Community College June 13 and 14 – a record number for the college. Ninety-three students took part in Thursday's GED and Adult High School Diploma ceremony, while 318 students participated in Friday's degree and certificate ceremony.

In 2013, 415 total students earned the GED (General Education Development). The oldest person earning a GED was 64, and the youngest was 16. Twelve students earned an Adult High School Diploma.

During the 2012-13 academic year, CCC conferred 1,520 degrees and certificates. The oldest student earning a degree or certificate is 69, and the youngest student is 17. One hundred graduates earned a 4.0 cumulative grade point average, and 542 earned a cumulative GPA between 3.5 and 3.989.

## Clackamas County Formally Adopts Fiscal Year 2013-14 Budgets Total- ing \$799,495,913

The Clackamas County Board of Commissioners formally adopted Fiscal Year 2013-14 budgets Thursday, June 27. The action followed a series of public hearings by the County's budget committees in May to discuss, amend and approve before sending them for board approval.

The newly adopted budgets total \$799,495,913, which includes property taxes, dedicated State and Federal funds, grants and other revenue sources. The budget for Clackamas County is \$602,381,979, a reduction of 2 percent from the current fiscal year budget.

In recent weeks, the Clackamas County budget committees held a series of public meetings to discuss the bud-

## State Fire Marshall Encourages Fire Safety With Outdoor Cooking

With the onset of warmer, dryer weather, State Fire Marshal Mark Wallace reminds Oregonians to be fire safe during barbecues and cookouts to avoid tragedy during summer activities. From 2008 through 2012, there were 203 grill-related fires in Oregon, resulting in nine injuries and more than \$4 million in property loss.

"Cooking outdoors is a nice way to enjoy Oregon's wonderful summers with family and friends, and following a few basic outdoor cooking fire safety tips will help keep it safe," says State Fire Marshal Mark Wallace.

The Office of State Fire Marshal offers the following safety tips:

- \* Only use propane and charcoal grills outdoors. Using them indoors or in any enclosed space (e.g. garage) poses a fire hazard and exposes you and your family to deadly gases.

- \* Place grills away from the home siding, deck railings, and out from under eaves and overhanging branches.

- \* Place your grill a safe distance from play areas and foot traffic.

- \* Keep children and pets away from the grilling area; declare a three-foot safe zone around the grill.

- \* Periodically remove grease or fat buildup from catch trays to prevent it from being ignited by a hot grill.

- \* For propane grills, make sure to check the propane cylinder hose for leaks. A light soap and water solution applied

to the hose will reveal escaping propane quickly by releasing bubbles.

- \* Only use proper starter fluid for charcoal grills. Remember to keep it away from heat sources and out of the reach of children and pets.

- \* Never add starter fluid when coals or kindling are already ignited.

"Also, make sure you dispose of ashes properly," says Wallace. "Even though ashes may feel cool to the touch, treat them as if they are hot. Soak them with water and place them in a nonflammable container. Store the container away from things that can burn."


The guest speaker was Clackamas County Commissioner Paul Savas.

Mr. Savas discussed current transportation issues in the County. One is the Sunrise Corridor. This project has been talked about for over 20 years. It is now in Phase I. This new roadway will allow traffic to flow from 122nd to Hwy 224 near the intersection of I-205. This will solve one of the biggest transportation bottlenecks in the County.

When the financing for this project was discussed Mr. Savas said that none of the cost of the project would come from the money received from the gas tax. Currently, the County receives 22 million/yr from gas taxes. However, 40-44 million is needed. Clackamas County doesn't have the funding mechanisms in place that Multnomah and Washington Counties have. The County is looking at vehicle registration as a funding source. Any proposed increases will be brought before the voters for approval.

The County is also losing their Urban Renewal District. The funds left in the district will go to roads. However, when that money is gone there will be no more unless another district is formed. He stressed that the County is not committed to do that at this time.

He also shared that the County Commissioners have begun a program that will effectively enhance community outreach. Each Commissioner is assigned a geographic region within the County. This will put the Commissioner in touch with organizations within the area which will facilitate communications between the Commissioner and the con-

stituents in that area. The Commissioners will be assigned a region every 6 months. This way they will be exposed to both urban and rural areas. For the first six months Mr. Savas will be assigned to Outreach Area 3 which includes the areas of Damascus, Gladstone, Happy Valley, Oregon City and Carus; Carver-Logan, Clackamas, Clarkes-Highland, Holcomb-Outlook, Redland-Fischers Mill-Viola, Sunnyside United CPOs and the Hamlet of Beavercreek. James Lindsey, a local Boy Scout, who is working towards his Eagle Scout ranking, approached those present with an idea for one of his projects. He proposed building four picnic tables for either the Korner Park in downtown Beavercreek and/or the park on Leland Road. He asked for support from the Hamlet for the cost of the lumber. After discussion the board suggested a message center. A message center/kiosk has been talked about for several years and now that the paper drop box has been moved from the front of the Korner Park to the corner of S. Joan Martinez, Secretary, read the highlights of the May 22, 2013, meeting. The minutes were approved by acclama-

There were four land use applications up for consideration this month.

There was an 80 acre parcel on Steiner Road requesting to partition into 2 parcels. This partition is allowed under Measure 49. The Hamlet decided to take no action.

There was a request for an extension on a current application on S Buckner Creek Rd. Since the project is done there was no action taken.

There was another application for a Forest Template Test to divide 80 acres. This application had already been approved by the County before this meeting.

There was a Temporary Dwelling Permit for Care application on Starview Lane in Oregon City. There were neighbors at the meeting who gave testimony about the property and their reasons why this application should be denied. This same testimony will be sent to the County. It was voted to recommend denial of this application based on testimony given.

There were no Land use decisions at this time.

There was a Treasurer's report given by Cheryl Boffard.

Under old business there was an update on the land use application for the Hals Paving property on S. Hwy 213.

There were then updates on community activities for the next month:



Nestlé proposes to draw 100 million gallons every year from this crystal clear water source naturally filtered by Mt. Hood's forests.




