Perhaps you have seen the signs draped over the old signs at the Beavercreek Saloon and Restaurant, "Under New Ownership".

It is true, the saloon and restaurant have been sold to Richard Holliday. Holliday, born in Myrtle Point, Oregon, and a resident of the Hamlet of Beavercreek, has been an Oregon resident for over 50 years. He was previously the owner of Doc Holliday's Pub in downtown Oregon City. Since then he has owned ten very successful restaurants and sports bars. The lessons learned in those establishments are now to be applied in our little community.

The new names chosen for the saloon and restaurant will be "Buffalo Bill's Saloon" and "Kissin Kate's Café" in keeping with the rural character of the Beavercreek community.

If you frequent these two businesses you will be aware of some of the changes that have already taken place. New flooring in the Café, raising the booths so that they are easier to get in and out of as well as fresh baked pies and cinnamon rolls daily. This is accompanied by new cooks in the kitchen.

The outside of the building has been painted and the grounds are being cleaned up.

This is just the beginning of many proposed changes and improvements.

In "Kissin Kate's Café" you will find some welcome changes to the menu. There will be a \$1.99 and \$2.99 weekly breakfast specials served Mondays thru Fridays from 7:00 to 10:00 a.m.

Allann Brothers Coffee has also been brought on board. The coffee is fresh roasted every day!

For the large appetite the Café will offer a new gourmet half pound burger menu.

There will also be a new pasta menu as well as everyone's favorite, strawberry shortcake when in season. No menu would be complete without ice cream and this menu is no exception.

Also, Saturdays and Sundays a Prime Rib Specialty Breakfast will be featured.

Pizza ovens are to be installed and students with an Oregon City Student Card will be given a 10% discount. Pizzas will also be available for large groups and parties.

The idea for the Café is to have a rural/diner appeal. Complete with some of the things we all remember from the past (at least those of us who are young enough to remember!)

Tax Season? It's Scam Season Too!

Now that you've filed your Oregon income tax return, what's next? Making sure you don't fall for identity theft scams, that's what.

A new e-mail scam asks you to file a corrected return because you made a mistake. The e-mail looks official, and asks you to mail information. But the address isn't for the Department of Revenue. "The e-mail seems legitimate," says Joan Linn, customer service center manager, "but it's not."

You can check the Department of Revenue's mailing addresses by visiting www.oregon.gov/DOR/poboxes.shtml.

The Oregon Department of Revenue doesn't send e-mails asking for sensitive information. "We only e-mail taxpayers when they've asked us to," says Linn, "and we suggest they don't send confidential information through e-mail, even to us."

Other times, scammers pose as a representative of a company that claims to work with, or for, the Department of Revenue. "We do work with vendors that regularly contact taxpayers; if you're unsure, you can call us to check," Linn says.

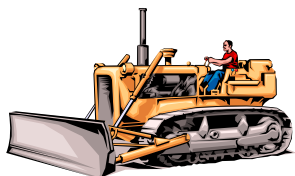

Clackamas County Has First Confirmed Case of Swine Flu

An adult from Clackamas County was among 45 confirmed cases of H1N1 swine flu confirmed by Oregon Public Health officials.

The confirmed case was a 51-year old male. He was not hospitalized and is recovering, according to health officials.

Of the 45 confirmed cases. Twenty are children, nine are teens and 16 are adults. This was the first confirmed case involving a Clackamas County resident.

Epidemiologists with the Oregon Public Health Division continue working with hospitals and County health departments to track the progression of H1N1 swine flu throughout the state.

H1N1 swine flu are similar to those for seasonal flu and may include fevers of greater than 100 degrees F or 37.8 degrees C; sore throat; cough; stuffy nose; chills, headache or body aches; fatigue and in some cases, diarrhea and vomiting.

Spread of the H1N1 swine flu virus remains a public health concern. Residents are urged to continue to take the normal safeguards to avoid any respiratory illness.

Cover your nose and mouth with a tissue when you cough. Throw away the tissue in the garbage after you use it.

Wash your hands often with soap and water, especially after coughing or sneezing. Alcohol-based hand cleaners are also effective.

Avoid touching your eyes, nose or mouth to avoid spreading germs

Avoid close contact with sick people

If you are ill, stay home and avoid spreading your illness to others.

The public may ask questions of public health professionals by calling the hotline at 1-800-978-3040. The hotline is staffed weekdays from 8:00 a.m. to 5:00 p.m. E-mail questions can be directed to flu.help@state.or.us.

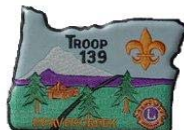

Stone Creek Golf Club Makes Top 10 National List of 'Green' Courses from *Links Magazine*

Stone Creek Golf Club, a Clackamas County park, was named one of the top 10 courses in the nation for its environmental friendliness. Leading the way are those courses that Audubon International has certified as sanctuaries, including Stone Creek.

The Peter Jacobsen/Jim Hardy design south of Oregon City was constructed with wildlife corridors to avoid disturbing nature as much as possible.

These green spaces have been recognized for their practices, which include limited pesticide use, enhanced wildlife habitats and initiatives like solar-powered carts and geothermal clubhouses.

Stone Creek is a Certified Audubon Cooperative Sanctuary. Stone Creek's extensive drainage system feeds the holding ponds from which the irrigation is drawn. All of the water features at Stone Creek are buffered to create an extra level of protection from runoff. The buffer strips of vegetation also create habitat for a large variety of waterfowl.

Links Magazine's is the first list to recognize golf's greenest courses. Pebble Beach is number 9 on the list; Chambers Bay in University Place, Wash., near Tacoma is listed as number 3.

The course at Stone Creek has an integrated pest management program that uses pesticides sparingly and only irrigates in-play areas, allowing other areas to go fallow in the summer to provide habitat for ground-nesting birds, one of many nature enhancements.

The lakes are 100 percent buffered and the water is tested twice annually.

David Phipps, Stone Creek Golf Club's maintenance su-

perintendent, received national recognition earlier this year for environmental stewardship in 2008 on the golf course from *Golf Digest* and Golf Course Superintendent's Association of America.

Phipps works with the local Audubon Society to provide annual birding and golf course tours for sixth-graders. Phipps also teaches a class called "Golf Course-Quality Lawns" to inform local residents how to properly care and cultivate their lawns using environmentally sustainable practices.

County Commissioners Applaud Willamette Falls Locks Funding

The Clackamas County Board of Commissioners have recognized and thanked the U.S. Army Corps of Engineers for awarding \$1.8 million in Federal Stimulus Funds to inspect and repair the Willamette Falls Locks in West Linn.

"These funds are so important to the economic vitality of Clackamas County," said Commission Chair Lynn Peterson. "We are grateful to our congressional delegation, Oregon Solutions, and the Corps for working tirelessly to keep the Locks in operation."

"The economic and environmental benefits of the Willamette Falls Locks to Clackamas County and the region are immeasurable. The Locks serve as the gateway to commercial, industrial, and recreational traffic on the Willamette River," said Commissioner Ann Lininger. "This funding is very good news to the citizens of the County."

These funds will be used to complete the federally required hydraulic and steel structures inspection, which is essential to keep the Locks operating. Congress awarded

funds last year to maintain and operate the Locks. Clackamas County and other agencies have requested continuation of federal funds next year to ensure the Locks remain in operation.

The funding is a portion of \$4.6 billion appropriated to the Corps from the Stimulus Bill signed into law by President Barack Obama in February. The \$4.6 billion is to be used for Civil Works projects and was distributed to the Corps districts on April 28, 2009.

The Willamette Falls Locks in Oregon are listed on the National Register of Historic Places and remain the oldest continually operating multi-chambered canal and navigation lock system in the United States. Oregon Governor Ted Kulongoski designated the Willamette Falls Locks an Oregon Solutions project and a coalition of more than 20 public and private-sector organizations has contributed more than \$500,000 to keep the Locks operating.

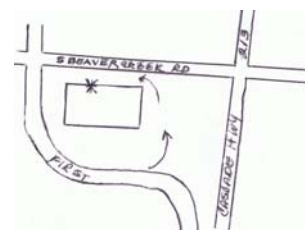

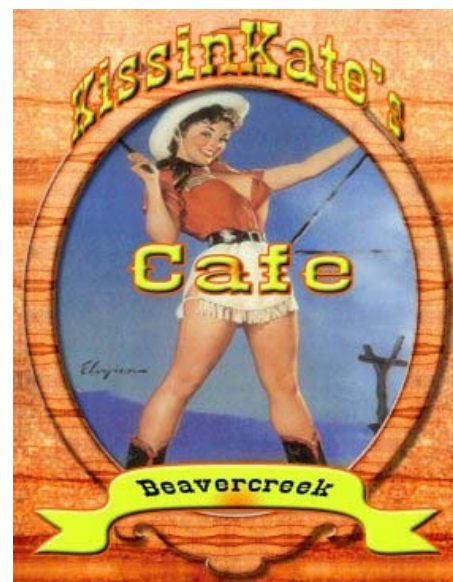

New Estacada Lake Boat Launch Opened May 15

Portland General Electric (PGE) and the Oregon Parks and Recreation Department (OPRD) opened a new public boat launch on Estacada Lake May 15.

Owned by PGE and managed by OPRD, the new launch site is on the Milo McIver State Park side of the lake. Motorized boating on the lake has been limited since the closure of a launch at PGE's Timber Park and the construction of a new fish ladder. The launching site was relocated to the State park to comply with federal licensing requirements for River Mill Dam on the Clackamas River.

The new launch facility was built as a joint effort involving the Oregon State Marine Board, the Oregon Wildlife Heritage Foundation, PGE and OPRD. It includes restrooms, parking and an ADA accessible fishing platform funded by the Oregon Wildlife Heritage Foundation.

Milo McIver State park is on Springwater Road, four miles west of Estacada and 25 miles southeast of Portland. A new road off the park's main road near the campground leads to the launching facility's parking area.

Department Trims Regence Request For Rate Increase

The Department of Consumer and Business Services turned down a 19 percent rate increase request by Regence BlueCross BlueShield of Oregon for its individual health plans and instead approved a 14.7 percent increase, effective July 1, 2009.

The department's Insurance Division reduced the rate to the lesser amount after analyzing the rate filing. The division concluded that Regence's projections for claim costs were too high. In addition, the 19 percent increase included a proposed 1.9 percent contribution to surplus, which the division did not find appropriate considering that the same group of policyholders experienced a 26 percent average increase in premiums last year. Oregon insurers are required to maintain surplus, and, despite the losses in its individual plans, Regence's surplus remains healthy. Regence has lost more than 7 percent on its individual health plans in the past year, even with the 26 percent increase last year.

The rate increase affects about 79,000 members statewide. Consumers who buy individual health policies generally do not have access to group coverage through their employer or choose to decline group coverage. The 14.7 percent increase is an average; a particular individual's increase may be larger or smaller.

The Insurance Division regulates health insurance rates in the individual, small group, and portability markets. It reviews rate filings to determine whether the benefits are reasonable in relation to the premium charged.

"After careful analysis of the company's data, we determined that the original request needed to be reduced," Act-

ing Insurance Division Administrator Teresa Miller said. "With health care costs making up a bigger portion of consumers' budgets, we expect insurers to use a sharp pencil."

The department is working with other state agencies and industry stakeholders on broad statewide health reform efforts, to control costs as well as improve quality and better the health of Oregonians.

When Regence proposed the 19 percent increase in March, the Insurance Division opened a month-long written comment period for anyone who would be affected by the outcome. Most of the comments the division received were from consumers, who said the increase was unreasonable. Clackamas County Dispatchers Save The Day and Help Locate Female Trampled By Horse

On Wednesday, May 6, 2009, at 9:00 a.m. a seriously injured female dialed 911 from her cell phone and connected with Woodburn Police Dispatchers. This 911 call was very broken and only bits-and-pieces of the call were decipherable to the initial call takers at the Woodburn dispatch center.

Woodburn contacted the Clackamas County Communication Center <http://www.clackamas911.org/> (C-COM) in Oregon City, and conveyed this limited and critical information received to Clackamas County dispatchers. These Clackamas County Dispatchers did a commendable job cultivating this limited information received into a successful mission, and are considered directly responsible for ultimately pinpointing the exact address of the injured female known only as 'AMY'.

With the information provided by Woodburn dispatchers, C-Com dispatchers began searching data bases for the only

four words recognizable in the 911 call. The four primary words were the name of 'Amy'; Ladd Hill; something perceived as Stramer and Equestrian.

Dispatchers passionately searched data bases and even called a variety of equestrian related business in their quest to locate the injured Amy. With no luck so far, dispatchers ran the law enforcement data bases and located a Michael Streimer (sounds like Stramer), with a residential address on SW Ladd Hill Road, in Wilsonville.

Clackamas County Sheriff's Deputy (Wilsonville P.D.) John Zbinden had been dispatched to the SW Ladd Hill Road area earlier in an effort to locate any equestrian centers. Coincidentally, Deputy Zbinden was presently making a u-turn in the residential driveway of 28495 SW Ladd Hill Road, when dispatchers contacted him on the radio providing him with their discovered 'potential address' on Ladd Hill Road.

Deputy Zbinden contacted the owner of the property, Michael Streimer (who is disabled), at home who informed the Deputy he was under the impression 'Amy' was in the basement apartment. This apartment was searched by Deputy Zbinden, but was unable to locate anyone.

At 10:30 a.m. Deputy Zbinden went to the barn on this property and located this person known only as Amy on the floor of the horse stable. She was sprawled-out on the floor of stable, bleeding and surrounded by vomit.

Amy was seriously injured; however, was able to tell this Deputy she had gone into a horse stall earlier at 9:00 a.m. and discovered a horse had a hoof wedged into the stall door track. While attempting to dislodge the hoof from the track, the horse kicked Amy in the head knocking her down under the horse. This animal became frightened and began to trample and stomp Amy while she was dazed and trapped under this trouncing horse.

Amy indicated she was only able to crawl out from the

The meeting was called to order by Chair, Bill Merchant, at 7:07 p.m.

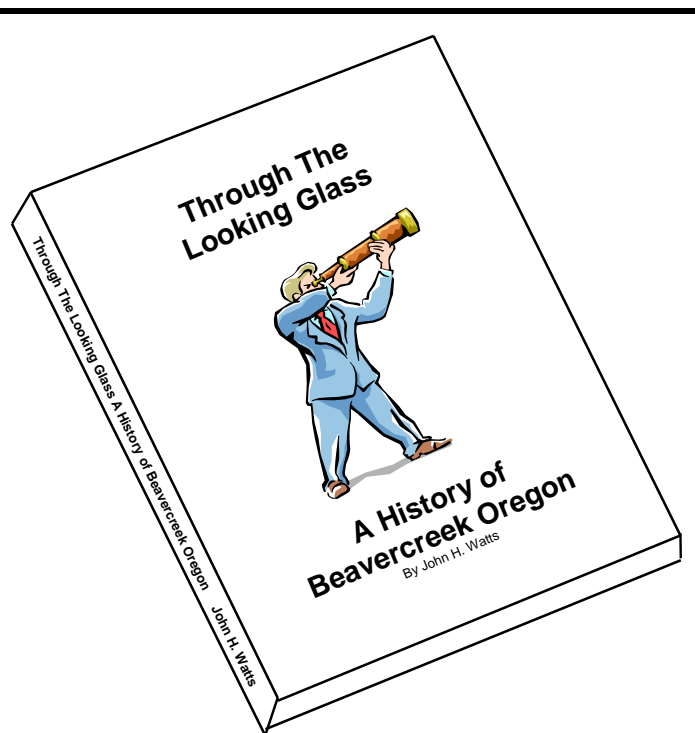
There was no guest speaker.

They have requested that they be allowed separate five-year terms for Phases 3 and 4.

The Molalla River School District wishes to reopen Scheubel School.

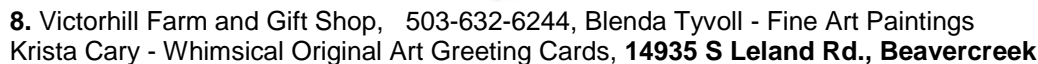

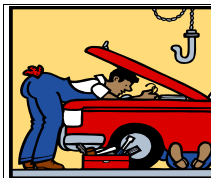

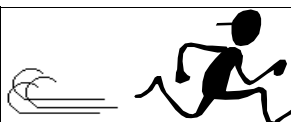
