
BCCP In The News

Beavercreek CPO Elects New Officers

A record crowd attended the February 24, 1999, CPO meeting to elect Officers and the Board of Directors to two year terms. The team of Norm Andreen and Chuck Lyons were elected as Co-Presidents. Both Norm and Chuck pledged to maintain the organization as a nonpolitical, neutral forum for all members and to provide a conduit for information from governmental agencies to the community. Their hope is to increase citizen involvement and to have the CPO work more closely with Clackamas County to provide community input and vision early in the planning process to better plan for Beavercreek's future. Elected as Speaker, Matt Badeau, will submit CPO land-use opinions to the County and represent the CPO's views at land-use hearings before the County Commissioners and, if necessary, before Metro concerning regional planning issues affecting the Beavercreek area. Elected Co-Secretaries, Joan Martinez and Sharon Charlson, will keep accurate minutes of meetings and submit them as legal records to County government. The election of the Board of Directors provided a challenge since 5 people were running for 3 positions. In a truly unique voting method, voters surrounded the candidate they supported as Directors were elected for each position. Elected were long time Beavercreek residents, Dwayne Rinkes and D.A. Hilderbrand. Also elected, Allen Burr, a newer resident, brings to the Board years of CPO experience from the active role he played in the Sunnyside CPO, as an Officer and Director. Outgoing President, Bruce Powell, fills one Borad position and will provide guidance for the new Officers and Directors. The new Officers and Directors hope to see more residents participate in the CPO and encourage you to attend meetings.
