## Beavercreek Hamlet Organizational Meetings To Be Held

The Clackamas County Board of Commissioners has given the green light for the Beavercreek Community to start the process to become a Hamlet. In the past, we have only had a say on land use issues via the Beavercreek CPO (Community Planning Organization). Becoming a Hamlet will allow us to also voice our concerns to the County on additional issues, such as traffic control, growth and planning. Additionally, we will be able to talk directly with other governmental agencies, such as Metro and Oregon City, representing a formal and recognized community of the Beavercreek Hamlet.

Over the next few weeks, we will be gathering input from the community, forming committees to write by-laws, and developing a slate of nominees for Board of Directors positions. The more voices that are brought to the process, the more successful it will be.

Every Beavercreek resident is encouraged to come to the meetings and participate. The first few meetings will be held as an adjunct to our regular CPO meetings. As work progresses, we will hold town hall meetings just for the Hamlet process. Please come and participate. You are needed as we begin this process of making us a stronger community.

## Thefts at Two Local Businesses

The thieves also entered through a window on the property and made off with various power tools including a Skil Saw, staplers, a Dewalt corded drill and three or four different screw guns.

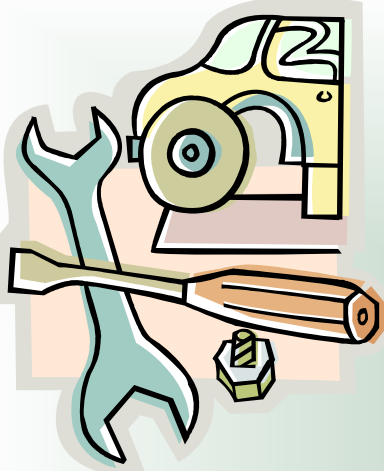

## "Beavercreek Oregon a History Through the Looking Glass"

*This is Part XLV of a series of articles on the history of the Beavercreek area. Written by Jack Watts, whose family were some of the early settlers of the community. This history is reprinted from his original manuscript that had until now never been published, by permission of Gordon Watts. We dedicate this series to a man and his love of the Beavercreek countryside who took the time*

--- THE BEAVER CREEK HALL AND BUILDING ASSOCIATION (CONT.) ---

In May of 1900 the Association decided to buy an organ but stipulated the price not exceed \$75. One was obtained for \$53, and was purchased on the installment plan with agreement to pay \$5 monthly. Five dollars was advanced for freighting it to Oregon City, where a Mr. Phelps hauled it by team and wagon to Beaver Creek for \$7.65. The Grange was charged \$3 for its use for the balance of 1900. It was noted that

the building was insured with the Grange Insurance Co. for \$600, which was conditioned on placing a brick chimney in the new kitchen.

In June of 1900 they voted to sink a well immediately. The sinking took five days, and the sinker was paid at the rate of \$1.85 per day and a total paid out for it as \$7.50 (which seems in error).

A meeting was held at the Grisenthwaite home on September 17, 1900 to discuss the origin of the fire that destroyed the Hall and its contents. A discussion about hiring a detective at a cost of \$90.65 was considered, but it was eventually voted to offer a reward of \$250 to be paid to anyone providing information leading to the conviction along with an additional \$50 as an added

incentive.

At a meeting held on July 27, 1901, bids were called for building a new Hall 26 feet by 50 feet. As a result, three bids were submitted: Tucter's - \$744.50, Moehnke's - \$560, and G. Bluhm's - \$515.80. The bid from G. Bluhm was accepted.

Notices were posted in the new Hall proclaiming that,  
**"NO LIQUOR OR PROFANE LANGUAGE  
 PERMITTED IN THIS HALL"**

Henry Hughes was designated to preserve order at all dances. In November of 1902, they voted to build a "privy" on the northwest corner of the lot. Over the years the size of the Association had dwindled, and the ownership now rested with three of the original owners. These surviving members offered to sell the property to Central Grange No. 276 for the sum of \$800. The Grange took the matter under consideration and a lot of time was consumed in debate as to whether to buy this property or to look for a new site upon which to build a new hall, as one faction proposed. It was a very uncertain time; decisions were made, only to have them reconsidered and tabled to recall and reconsider, and matters hung in the balance.

This was at a time when the Hall people came up with an offer to lower the offering price to \$700. Then at the December meeting of 1927, the Grange finally authorized the Master, Secretary and Treasurer to proceed to

acquire the Hall Association's property, to execute the necessary papers, note, mortgage, and to draw upon the Grange treasury in the amount of \$300 for use as a down payment, which left a balance of \$400. It was in this way that the land that the Grange had sold in 1899 for \$11.55 to the Hall and Building Association was restored to the ownership of Central Grange No. 276. The name was changed to Beavercreek Grange No. 276 in February, 1973.

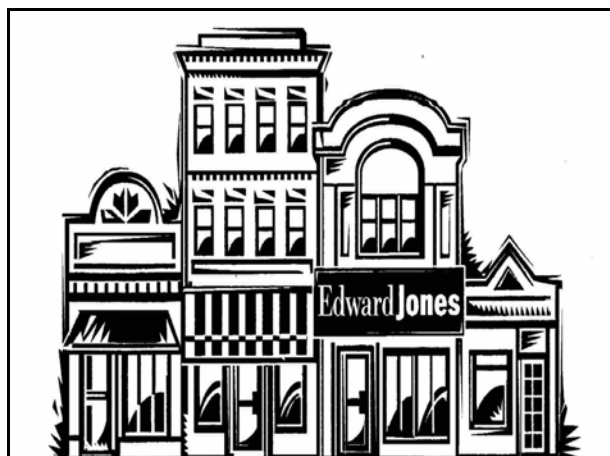

## Fatal Traffic Crash Gearhart Beach/OceanShore

A Beavercreek, Oregon man died late Monday, April 3rd, after the pickup he was a passenger in rolled on the beach in the Gearhart area as the driver was doing "cookies". Two other passengers were injured, as was the driver who was also subsequently arrested on multiple criminal charges.

On April 3, 2006, at approximately 11:32 p.m., a black 1999 Toyota pickup driven by JOEL JUSTIN HIBLER, age 26, from Vancouver, Washington, was reportedly doing "cookies" on the Gearhart-area beach without lights in the sand and surf. As it cornered sharply in the surf, it rolled driver's side first an unknown amount of times before coming to rest on its wheels facing the ocean.

The pickup had four occupants who were all unrestrained, but did remain inside the passenger compart-

Development Cam Gilmour noted that "The schedule all depends on the weather. If we experience wet weather conditions, the project will be delayed until the slope dries out enough to resume work safely. We do not want to take chances with the safety of workers or the public."

Clackamas River Drive has been closed between Forsythe Road and Springwater Road since November 1st because of the possibility of landslides. That was the second time the County closed that stretch of the Drive

in 2005.

The first closure came on May 14, 2005, after a landslide. The County re-opened the road two months later after determining there was no further threat to public safety. Though there were no additional landslides in 2005, with fall and winter rains on the way County workers again closed the road November 1st to make sure the public remained safe.

Until the road re-opens, people who normally use Clackamas River Drive between Forsythe Road and Springwater Road can follow a detour on either Forsythe Road or Highway 224.

No leads are available to determine who may be involved in this activity and no in-

formation has been received indicating similar calls have been made in Oregon, but the public should be aware of the possibility of such calls.

On April 4, 2006, OSP General Headquarters in Salem received a phone call from a Minnesota woman inquiring about a phone call she received from a person identifying himself as "Lieutenant Johnson". This individual asked if she had a relative who lived out of state. She stated that she did have a son who lived in Oregon.

"Lieutenant Johnson" then said he was with the "Oregon Police" and was informing her that her son was involved in a traffic crash on an Oregon freeway, and that he was calling because "pre-authorization" was needed before her son could be transported by air from the scene to needed medical treatment. As part of



the "pre-authorization", she was requested to wire money to help pay for the medical transport by air. She stated that she felt this would take too much time so she asked if she could provide credit card information over the phone to pay for the cost.

"Lieutenant Johnson" said that would be allowed, so he transferred her call to another person who was the "dispatcher" for the medical air transportation service. The female "dispatcher" obtained the woman's credit card information over the phone. Prior to ending the phone call, the woman noted the phone call was blocked on caller ID so she asked for a callback number. She was denied the phone number because it was supposedly a phone line into "the dispatch center".

After ending the call, the woman said she called her son's phone number to get more information and learned he was OK and had not been involved in a traffic crash.

Due to varied phone scams soliciting personal and credit card information, the Oregon State Police, Legacy Emanuel Hospital and Life Flight Network caution anyone to avoid becoming a victim.

"No law enforcement agency should be acting as a go-between to obtain financial information for any business or service," said Captain Cynthia Kok of the OSP Office of Professional Standards. "A trooper or police dispatcher may call to inform someone of medical emer-

gency involving a family member, but that call is for the sole purpose of letting them know what has happened and where they will be transported to for treatment."

Life Flight Network Director Michelle Haun-Hood emphasizes that emergency patient care is always their first priority. "Pre-payment or pre-authorization for payment is never required at the time of transport to the hospital. Payment and insurance issues are dealt with after care has been provided," said Director Haun-Hood.

Remember:

- You should always be suspicious of anyone who calls requesting any information that can be used to utilize your credit card or financial institution records, no matter what purpose they claim it is for.
- If you get a suspicious call, get the caller's first and last name, department or company, and return phone number, including extension.

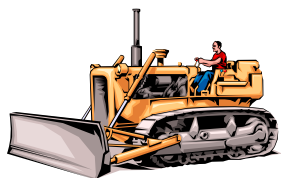

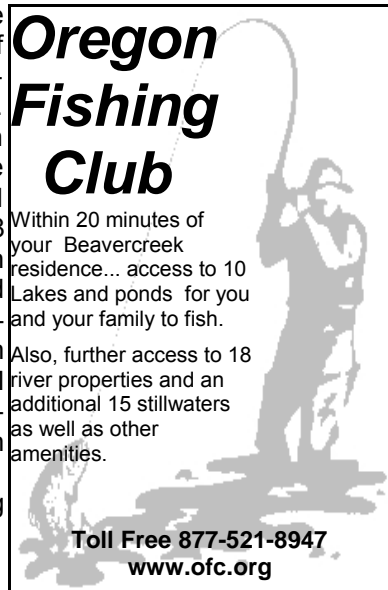

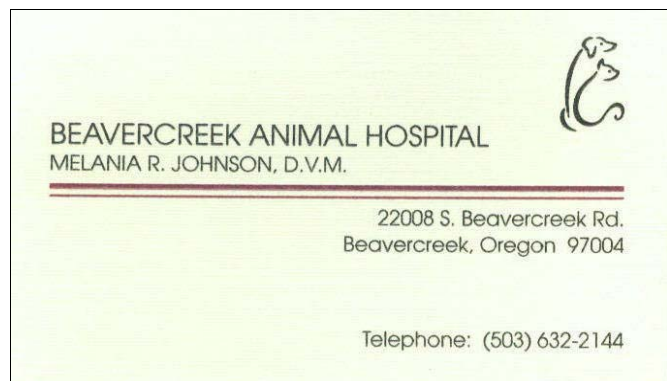

## Fatal Accident Takes Life

On Friday, April 14th, at 1:56 PM a fatal automobile accident occurred at the intersection of State Hwy 170 and South Barnards Road, in Molalla. Life Flight and an ambulance transported two additional occupants of a passenger vehicle, which collided with a fully loaded eighteen-wheeler, hauling lumber while traveling northbound on Hwy 170.

A witness to this accident reports she observed a "blur" enter the intersection, eastbound from S. Barnards Road, failing to stop at the controlled intersection at Hwy 170, and S Barnards Road.

Investigators report that this passenger vehicle failed to obey a stop sign at this intersection and immediately collided with the rear trailer portion of the truck, just in front of the rear wheels. The passenger vehicle was then dragged, wedged under the trailer, along the pavement for approximately 50' after impact.

The driver of the semi-truck George Clarno, 53 years of age, bound for the Port of Portland while operating this fully loaded Meadow Ridge Farms semi-truck, was not injured in this accident.

The Clackamas County Sheriff's Office, Crime Reconstruction and Forensic Technicians (CRAFT) were summoned to the scene and are conducting the investigation. Alcohol does not appear to be a factor; however, appropriate drug testing results are not immediately available.

The name of the deceased passenger, the hospitalized driver and rear passenger, with the passenger vehicle description involved are identified as:

Deceased, Thomas Arthur January, from St Paul, Oregon; Thomas January was situated in the right front passenger seat of this passenger vehicle with a seat belt buckled and in use.

Hospitalized driver Angelin Rose January, from Molalla and the daughter of the deceased passenger Thomas January. Operating a 1980, gold colored, Honda, Accord, 4-door sedan; registered to Angelin January. Unknown seat belt usage.

Hospitalized rear passenger Daniel K. Roth, from Molalla and declared fiancé of the driver Angelin January. Unknown seat belt usage.

It was noted that all the orange markings on Beavercreek Road in the core are for a new water line between the store and the grade school.

The Oregon City Planning Commission has actually invited two individuals from the Beavercreek area to sit on the Citizen Advisory Board that will be planning the Beavercreek Road improvements that are coming in the near future. This includes widening and lane changes.

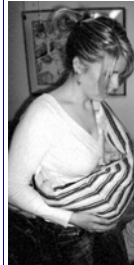

## Fire Safer Cigarettes Would Reduce Oregon Fires

Friday, April 21, a smoldering cigarette ignited nearby paper causing a fire in a mobile home and hospitalizing an Ontario resident. The unidentified woman was transported to the Oregon Burn Center in Portland, where she later died. According to Ontario Fire Chief Terry Mairs, who investigated the fire, the damage to the single family residence is estimated at \$5,000.

The Oregon Fire Safety Coalition wants the public to be aware that the technology exists to reduce cigarette-caused fires and could reduce fire deaths, injuries and property loss if it were in use in the state. Organizations statewide are supporting the Coalition's efforts to pass a bill in the 2007 Legislature requiring all cigarettes sold in Oregon be self-extinguishing. Fire-safer cigarettes use specially designed paper with "speed bumps" to restrict burning.

Oregon had 7,693 cigarette fires from 1999 through 2004 resulting in 30 deaths, 152 injuries and \$27.9 million in direct property losses. Oregon cigarette-caused fires result in about 250 structural fires per year with losses averaging more than \$4 million annually. Smoldering cigarettes may ignite dry vegetation or debris outdoors, furniture or bedding indoors, and are hazardous when improperly disposed as trash if they continue burning when thought to be out.

The state of New York's legislation requiring fire-safer cigarettes was implemented in 2004. Since then, fire deaths have been reduced by 50%. Oregon's proposed legislation will require the same standards as New York and laws recently passed by state legislative assemblies in California and Vermont. This same law is in legislative sessions in Illinois, Massachusetts, Maryland and New Hampshire.

In the first two weeks of March, Clackamas Fire District #1 responded to 6 home fires FORTUNATELY, NO ONE died in these fires. Nationally, nearly 140 people died in home fires during this time, and a startling one-third of those fires happened over a three-day period. Fires that kill are a sad reality of each and every day.

There is no single more important item in any household than a working smoke alarm. Nearly one third of residential fires and two-fifths of residential fatalities occur in homes with no smoke alarms. Put another way, having a working smoke alarm in the home reduces your chances of dying in a fire by nearly half.

Place a smoke alarm on every level of your home and outside bedrooms. Keep your bedroom doors closed, place a smoke alarm in each bedroom. Check the batteries once a month to make sure it works.

## Clackamas County Government Channel Nominated for Emmy

The National Academy of Television Arts and Sciences Northwest Chapter has nominated the Clackamas County Government Channel for an Emmy for the documentary "*Vortex I, A Biodegradable Festival of Life*."

*Vortex I* was a rock festival held at McIver State Park in Clackamas County in August of 1970. At the height of the Vietnam era, President Richard Nixon was scheduled to speak at the American Legion convention to be held in Portland. Hoping to avert extreme violence between thousands of anti-war protesters and those attending the convention, a group of anti-war activists and the state of Oregon orchestrated a way to keep the two groups separate: the late Governor Tom McCall ordered McIver Park to be used as a free rock festival.

While hated by some and worshipped by others the unprecedented state-sponsored plan worked. The convention went on as scheduled and nearly 100,000 festival-goers went to McIver and partied. There was little violence and no major confrontation. It also created the biggest traffic jam in the state's history.

The documentary is the story of what led up to *Vortex I*, how it was planned and how it played out. Based on the book "The Far Out Story of Vortex I" by author Matt Love, the documentary has rare film footage of Tom McCall discussing the event and behind the scenes look at the event itself. It also features interviews of persons who attended *Vortex I*.

Terry Musgrove produced the one-hour documentary in 2005. It was nominated in the "*Documentary - Cultural/Historical*" category along with eight other northwest productions.

The Emmy winners will be announced June 3rd at the 43rd Annual Northwest Regional Emmy Awards Presentations in Seattle. "We are extremely proud that this project has been considered for an Emmy," said Clackamas County Cable Manager Debbie McCoy. "This was a

unique event in the history of Oregon and the documentary represented it very well."

## Clackamas County Dump Stoppers Program Receives National Award

The Clackamas County Dump Stoppers program has been named an **Exemplary RAC (Resource Advisory Committee) Project** by the National Forest Counties and Schools of America Coalition.

Dump Stoppers received this recognition on April 7th along with the Hood-Willamette Resource Advisory Committee. Dump Stoppers was selected for this honor from among 63 projects nominated from across the country because it has succeeded with broad community support.

The Dump Stoppers program has made a substantial difference in reducing the amount of illegal dumping in Clackamas County since it was created by the Board of County Commissioners four years ago. It is funded by grants made possible by the federal "2000 Secure Rural Schools and Community Self-Determination Act," commonly known as payments to counties or Public Law 106-393, sponsored by Oregon Senator Ron Wyden and Idaho Senator Larry Craig.

The **Dump Stoppers Program** was created four years ago to deter illegal dumping and vandalism on forest lands in Clackamas County.

A full-time Clackamas County Sheriff's Deputy, working with an assistant from the county's Community Environment Division, tracks down illegal dumpers and vandals. The District Attorney's Office conducts prosecutions and community corrections crews clean up dumpsites.

## Exercise and Advocacy on Tap for Aging Issues

Spring term Aging Issues sessions will discuss low impact exercise and how to advocate. Aging Issues sessions are sponsored by Clackamas Community College and take place one Monday a month from 10:00 a.m. to noon at the Pioneer Community Center, 615 Fifth Street in Oregon City.
