#### Have You Seen The Light?

Our signature "Hamlet of Beavercreek" sign is now illuminated for night time visibility

This lighting project was approved several months ago after Dee Church volunteered to manage the project and recommended the use of high tech, low power hardware for the installation.

Now, a whopping 8 watts of LED power on each side of the sign will consume about \$10 worth of power annually, and the fixtures can potentially operate for a couple of decades with no maintenance.

The lights are mounted on "runaway truck" proof security pedestals fabricated by Dee Church, Griff Crooks, and John Burke. The electrical installation was managed by Scott Stein who donated a low voltage transformer and some other electrical supplies. Many thanks to our Sunrise Lane delegation, Scott, Griff and John, and also to Steve Bland at Skyles Drilling who authorized the electrical connection to their power grid service.

Dee Church comments that, "while night time visibility is impressive considering only 8 watts of power, I'm disappointed with the reflectivity of the white lettering on "The Hamlet Of" slab carved last year by John Hoult. We achieved excellent adhesion of the glass beads to the white PoxyCoat paint, but the "V" shape of the indented, carved letters minimizes on-axis reflections. As you drive by the sign, the white letters get much brighter as you view the letters from the side due to more light reflecting back from the edge of the letters. Perhaps, in our spare time, we can rework the whole thing with some touch up carving, new paint and more reflective beads. I believe that our sign will light up like neon with the proper application of those beads and 8 little watts of LED power."

#### Help The Beavercreek Lions Fill Christmas Food Baskets

This featured collection enables library users to discover and download thousands of free classic eBooks, in the industry standard EPUB format, without holds or waitlists.


Library2Go users can visit the Project Gutenberg collection webpage http://library2go.lib.overdrive.com, search for titles, hit the download button, and save the free eBook to their computer. The titles can be read in any EPUB-compatible software and transferred to EPUB-capable eBook readers such as the Sony Reader, nook, Kobo or Apple iPad, iPhone or iPod Touch.

The Project Gutenberg collection expands and enhances Library2Go by making thousands of classic eBooks available without waitlists or holds. The Oregon Digital Library Consortium was formed in 2005, with the purpose of delivering electronic resources,

such as downloadable audiobooks, video and eBooks, to participating libraries statewide. Library2Go is supported in part by the Institute of Museum and Library Services through the Library Services and Technology Act, administered by the Oregon State Library.

#### CCFD Board Meeting Held Oct 18

The following took place at the board meeting on October 18, 2010.

The Board continued discussion regarding the updating of its Urban Renewal Policy. Guests providing comments on this topic were TVF&R Chief Mike Duyck, SDAO Representative Mark Landauer and citizen Steve Schopp. Comments from the discussion that followed will be incorporated and a revised draft will be presented at the November 15, 2010 board meeting for approval.

The Board approved the changes to Board Policy 4.4 regarding collective bargaining agreements.

The Board approved Resolution 10-08 – Sole Source Purchase for Proprietary Software Licensing.

Senior staff met on October 13 for a retreat follow-up meeting. The following was discussed:

The weekly staff meetings will be replaced with a monthly Strategic Organizational Planning Session on the first Tuesday of each month beginning January 4, 2011, at Station 5 from 9:00 a.m. – 12:00 p.m. The format will be revised to include a refocused and reformed agenda.

Content will focus on the strategic organizational plan and progress on strategic goals. Division heads and directors will be the core of the group and will each be inviting two to three different staff from their areas to attend each meeting. This will help provide for continued employee engagement in the progress of the District and in enhanced communication.

The Hot Sheet will be distributed on the first and third Tuesdays of each month. It will focus on the events and news that is taking place in the District as well as providing an update on the outcomes of the Strategic Organizational Planning Sessions.

The Confederated Tribes of Siletz Indians has awarded the SWIFT Program with a \$15,000 grant that will be presented on November 15, 2010 at Chinook Winds. This grant will provide funding for the SWIFT team to complete their training, which will enable them to begin responding regionally and nationally to swift water and flood rescues.

#### Oregon Receives Additional \$82.7 Million For Foreclosure Prevention Programs

The U.S. Department of Treasury has announced that Oregon will receive another \$82.7 million in Hardest Hit funding for foreclosure prevention activities. Oregon's allotment is part of an additional \$3.5 billion Treasury has released for the 18 states and the District of Columbia that currently participate in the Hardest Hit Fund to help stabilize their housing markets.

The Obama Administration has been considering making additional Hardest Hit Funds available as the housing market has not shown improvement. The new funding allows the states receiving Hardest Hit dollars to expand their foreclosure prevention programs to reach more struggling homeowners.

Oregon will add the funds to its already approved Oregon Homeownership Stabilization Initiative programs to be implemented beginning early next year.

#### The Need For Blood Is Constant.

The American Red Cross is asking eligible donors to make blood donation a priority on their to-do list. The need for blood is constant, and each day in the Pacific Northwest, the agency must collect 1,000 units of blood to help supply the needs of hospital patients. Blood products are routinely transfused to those with cancer and other diseases, premature babies, organ transplant recipients, and accident and trauma victims. Additionally, the Red Cross stresses that our blood supply is a matter of preparedness, and in the event of a disaster or unexpected tragedy, the blood must be on the shelves before it is needed in order to help save lives.

The Red Cross asks donors who already have scheduled appointments to keep their commitment. "A blood donation appointment is much like an appointment with your dentist or doctor. Once a blood donor schedules an appointment we set a donor bed aside for them." says Tim Lippert, donor recruitment manager. "Hospital patients across the country are in need of blood each day, and it makes a difference when donors do not hold their scheduled times.

Now that parents have their children back in school and the vacation season has come to a close, we are hoping to see a change in our cancellation rates."





# Fatal Traffic Crash On South Leland Road Causes Road Closure

On Friday, October 1, 2010, at 10:05 a.m. a maroon colored 1994, Toyota, 4-Runner, was proceeding westbound on S. Leland Road.

As it was approaching the intersection of S. Leland and S. Leslie Road, in Beavercreek, the driver of this westbound vehicle became momentarily distracted, causing this vehicle to depart the roadway on the north side of S. Leland Road.

As the vehicle and was returning to the roadway surface it struck an obstruction described as an asphalt driveway approach which launched the vehicle into the air. The airborne vehicle then traveled into the eastbound lane of travel and struck an oncoming eastbound vehicle.

The lone, 63-year-old female driver of this eastbound vehicle, a 1993 Subaru Impreza, died instantly in the resulting crash.

The deceased driver is identified as Nancy Lee Tonkin, 63, who resided with her family on S. Beavercreek Road in Beavercreek.

The driver of the westbound vehicle has been identified as Sydney Karlik, age 19 of Oregon City.

Sydney Karlik did not appear injured and did not require medical attention at the scene.

Both automobiles did not carry any passengers at the time of this crash.

#### 2010-2011 Property Tax Information

Tax relief from Oregon's other constitutional limitation, Measure 5, also increased from \$3.7 million to \$7.6 million more than doubling.

Most property owners will see their taxes increase close to the 3% expected with the typical 3% growth in assessed value. Others will see increases less than 3% as taxing districts levied less for bonded debt or paid debt off. Some will see increases greater than 3% where districts levied more for bonded debt or local option levies. Property owners located in the Tualatin School District boundary approved a new Aquatic Park District with a permanent rate of 9 cents per thousand and City of Tualatin property owners in Clackamas County approved annexation to the Clackamas County Library District with a permanent rate of 39.74 cents per thousand.

#### Clackamas County Offers Weatherization Assistance To Low Income Residents

Clackamas County provides free weatherization services to income eligible residents to conserve energy and promote healthy, safe living environments. The assistance is offered through the County's Community Solutions Division, a division of the Department of Health, Housing and Human Services.

Community Solutions has weatherized 359 low-income households in Clackamas County this year, many of which were homes of seniors, people with disabilities or young children. #### New Website Lets You Do More State Income Tax Transactions Online, Anytime

Do you do a lot of your financial business on the internet? Well, now you can check on and pay your State personal income taxes online, too.

"How Much Do I Owe?" is the Oregon Department of Revenue's secure interactive website that makes paying your state personal income taxes easier and faster than ever.

The site lets you make electronic tax payments. You can also check your tax balance and payment activity for the last 10 years. Soon, you'll be able to change your address and set up payment plans.

"This service is another step in our strategy to make it easier for people to pay their taxes," said Cleve Bench, Chief Information Officer. "For example, if you make a payment online, it'll show up in your account within two days."

The website went live in July. So far, nearly 4,000 Oregon taxpayers have visited the site.

"'How Much Do I Owe?' allows people to do business with us in a way that's convenient for them, when it's convenient for them," Bench said.

"How Much Do I Owe?" is the online cousin of the popular "Where's My Refund?" site in which taxpayers can track the status of their tax refund. The department

launched that site in 2005. Last year, it had nearly 900,000 unique visits.

#### State Program Provides Free Help With Medicare... Fall Open Enrollment Starts Nov 15

Nearly 25,000 Oregonians are enrolled in Medicare Advantage plans that will go away in 2011, meaning they will need to consider new insurance as Medicare's big enrollment season gets under way next month.

Many other Medicare recipients will want to review their health or drug coverage to make sure they have the best coverage at the best price in 2011.

Medicare's annual enrollment, from Nov. 15 through Dec. 31, is an opportunity for current or newly eligible Medicare recipients to join or change health plans and/or prescription drug plans. New coverage starts Jan. 1, 2011. Plans that are

not renewing their Medicare contracts for 2011 started sending notices to those affected last week. The notices explain coverage options.

"It's really important to save any mail from your Medicare health plan, which may include a non-renewal notice," said Lisa Emerson, manager of the State's Senior Health Insurance Benefits Assistance (SHIBA) program. "Our counselors can help you review your plan options between now and early December so you have a smooth transition in 2011."

The SHIBA program, part of the Department of Consumer and Business Services, trains volunteers throughout Oregon to help people compare Medicare insurance options and to see if they qualify for help with Medicare costs.

#### Some key issues to consider this year:

Many private-fee-for-service plans are leaving: About 25,000 Oregonians, or 12 percent of all those with Medicare Advantage plans in this State, must find new coverage by the end of the year. Most are in private fee-for-service plans that faced new consumer protections and did not renew with Medicare. Some of the counties most impacted are: Baker, Curry, Douglas, Harney, Klamath, Lake, Malheur, Sherman, Umatilla, Union, Wallowa and Wasco.

Some prescription drug plans going away: Another 1,321 Oregonians must find new prescription drug plans be-



cause their plans are not renewing contracts with Medicare. Changes in cost and coverage: People with Medicare Advantage Plans or Part D prescription drug plans that remain available in 2011 must receive Annual Notice of Change (ANOC) letters by Oct. 31. These letters describe important changes in coverage and cost for 2011.

Help with prescription drugs: Medicare helps pay for prescription drugs for those with a limited income. Senior Health Insurance Benefits Assistance counselors can help you apply or you can visit ssa.gov or call 1-800-772-1213. Ask about the "Extra Help" program.

#### Need help?

By mid-October, Medicare will mail the 2011 Medicare & You handbook and update its Plan Finder at Medicare.gov. Medicare can explain choices at 1-800-633-4227.

Personalized counseling is available through the Oregon SHIBA program. Call 1-800-722-4134 to be routed to an organization in your community for a one-on-one appointment with a certified SHIBA volunteer or to speak with customer service staff in the state office.

SHIBA also publishes the Oregon Guide to Medigap, Medicare Advantage & Prescription Drug Plans identifying Medicare insurance options in this state. The 2011 version will be available by late October at oregonshiba.org. The website also has a calendar of free Medicare classes that are offered in some communities.

#### Forecast Synopsis

"With a moderate to strong La Nina well underway, the majority of experts at today's annual forecast meeting predict a wetter and cooler than normal winter overall for Oregon. Snow pack in the Cascades is likely to be at or above normal this winter. In some analog (similar) years in the past, the Cascades have experienced near record snow amounts. George Taylor, Applied Climate Services Climatologist, LLC, Corvallis, Oregon, says, "wet, wild and windy weather is in store for the coming winter." Pete Parsons, Oregon Department of Forestry Meteorologist, Salem, Oregon says, "this winter is likely to be markedly different from last year. Parsons went on to say, "I would be surprised if we made it through this winter without seeing at least one arctic air mass and low elevation snow event." Tyree Wilde, NOAA-National Weather Service WC Meteorologist, Portland says, "wet, wet, wet this winter." Forecasters also noted that it has been 15 years since the last major windstorm to strike Oregon on December 12th 1995, which was also a La Nina winter that featured a record setting flood, arctic air and snow.

Norm Andreen, Co-Chair, ran unopposed for the Chair position. Joan Martinez ran unopposed for the Secretary's position, Bill Merchant, Past Chair, ran unopposed for a Director position. Due to the resignation of Dee Church as a Director and Tammy Stevens not re-running for Treasurer there are two unfilled Director positions open.

Norm Andreen told those present that he would like to continue the work begun by Bill Merchant, but that he will need the help and cooperation of the community. That means YOU getting involved.

land Road intersection. It is projected that there will be 120 trucks a day, the plant running 24 hrs, and 5,000 gals of water used a day in an area of residences with wells. There is also concern about air born contaminants.

If this land use action is allowed to proceed it will set a precedent in the County and further jeopardize the livability and property values of the residents of the area.

Norm Andreen said about 400 people attended the first meeting on the matter. The County is trying to figure out how many more meetings it will take to hear all the testimony as about 250 people were turned away from the first meeting due to room capacity issues. It may take at least two more meetings.

There was one land use issue before those present. A renewal for a manufactured home for care. It was recommended for approval.



Regional officials regarding denying the residents of the Hamlet of Beavercreek the opportunity to be heard on the proposed zoning change to 9+ acres in the "Beavercreek Road Concept Plan". Apparently, the proposed zone change is to allow the owner of the property to refinance his property to keep it out of foreclosure. In order to assist this land owner, the City of Oregon City has violated the State's mandated Goal I for citizen involvement and further shown its lack of respect for the residents of Beavercreek.

As a result of the letters the City has agreed to make sure that the Hamlet of Beavercreek, The Redland/Viola/Fischer's Mill CPO and the Leland CPOs will receive all future land use paperwork.

I'll believe it when I see it.

FINAL NOTE: Oregon City did not recognize the Hamlet's request to write the land use notifications into City code, they more or less blew us off.
