## Finally Some Rain!

It finally came... Rain...not just a sprinkle or two, but a real rain that begins the rehydration of our forests, grasslands, parched neighborhoods and rural properties.

This is the third year we have been in a drought and this year was a scorcher from a wildfire and gardening perspective. It is hard to spend over \$250.00/month for water and still see parts of your yard suffering and dying under the strain. Your shrubs may look okay now, but when spring comes and they start their new growth season some will not be able to take the strain and will die.

Especially hard hit the past three years have been the fir trees. They have really reacted to the lack of enough water. The needle fall this year has been prolific. There were so many needles you had to use a snow shovel to move them all into piles for removal. During the wind storm we had a month ago, there were a lot more branches that fell than in the past 30 years I have lived in Beaver Creek. This is also due to a lack of water. Hopefully, this winter we will get enough moisture, not in the form of ice and snow, so that our plants can begin to recover. Now... the Fall clean up begins! On that note, with Fall cleanup comes a lot of debris to be disposed of. Please, **remember**, the burning season begins on October 1st, but you still need to call the burn information number at 503-632-0211 to be sure it is a burn day before you proceed. If not you may face fines.

## Now That School Has Started Please Watch For Our Children

### School Bus Safety Tips For Drivers:

- On a two-lane road or street, motorists approaching a school bus from either direction must stop when the bus displays flashing red warning lights and extend the stop signal.
- Vehicles may not pass until the flashing red lights and signals are turned off.
- Never pass a school bus on the right. It is illegal and could have tragic consequences.
- Be alert! Children are unpredictable. Children walking to and from their bus are usually very comfortable with their surroundings. This makes them more likely to take risks, ignore hazards or fail to look both ways when crossing the street.

### For Kids:

- Get to the school bus stop five minutes early, so you won't have to run across the road to catch the bus.

## Federal Court Provides Temporary Relief From WOTUS

The day before the rule was set to be implemented, a Federal Court ruling in North Dakota sided with the National Cattlemen's Beef Association (NCBA) and Oregon Cattlemen's Association, blocking the Environmental Protection Agency (EPA) and the Army Corps of Engineer's "waters of the United States" or WOTUS rule, which was set to take effect August 28. The court issued a preliminary injunction, which blocks the agencies from moving forward with their rule, stating it poses "irreparable harm." Cattlemen and women agree, and have argued this point for more than a year-and-a-half to the agencies, only to be pushed aside.

Under the guise of clarifying the Clean Water Act, the rule changed the definition of what would be considered a "water of the United States" and, as such, fell under federal jurisdiction. As it turns out, the new rule would apply to nearly all waters across the country with nearly no bounds. For Oregon, that would mean stock ponds, ditches, and potentially even puddles.

"In Oregon, where there is typically an abundance of rain, a rule this broad and ambiguous could bring unnecessary hardship to Oregon's ranching industry," Kayli Hanley, com-

munication's director for the Oregon Cattlemen's Association said. "Oregon producers work hard to practice responsible water usage. This kind of a rule is like having an outside spectator come into the picture, ignore successful local initiatives, and say, 'we can do it better than you can.'"

NCBA Environmental Counsel Scott Yager explained that although the court's injunction is good news for cattle producers, there is still some uncertainty about the scope of the ruling.

"We believe the injunction applies nationally due to the language in North Dakota's order that halts implementation of the rule, which is a rule that's national in scope," said Yager. "However, EPA is taking a contrary position that it only applies to the 13 states in the case: Alaska, Arizona, Arkansas, Colorado, Idaho, Missouri, Montana, Nebraska, Nevada, New Mexico, North Dakota, South Dakota and Wyoming."

He said the injunction could last until the court hears the merits of the case, but it could be lifted earlier if EPA succeeds in a challenge against the injunction.

"Since this type of injunction is largely unprecedented, I would advise caution in relying on it as members consider projects that might affect jurisdictional waters in the near future," said Yager. "However, this is a great victory and sets an important precedent moving forward. We will continue our push in Congress as well in the courts."

Earlier this year the U.S. House of Representatives passed legislation with bi-partisan support which calls for the rule to be withdrawn. The Senate has a companion bill, SB1140 The Federal Water Quality Protection Act, which has passed through the Environment and Public Works Committee and is awaiting further action. Yager said the Senate bill would require EPA to withdraw the rule and start over, this time with stakeholders at the table.

Jerome Rosa, executive director for Oregon Cattlemen's Association, heartily agrees that EPA needs to give the rule another go around. "Multiple aspects of the rule were prepared through a flawed rulemaking process," he said. "The WOTUS rule in its current state should be withdrawn due to lack of quality assessment and biased rulemaking process."

On July 24, 2015, the Oregon Cattlemen's Association, along with Washington, California and New Mexico Cattlemen's Associations, signed on to a lawsuit through Pacific Legal Foundation against the Environmental Protection Agency and their Waters of the United States rule.

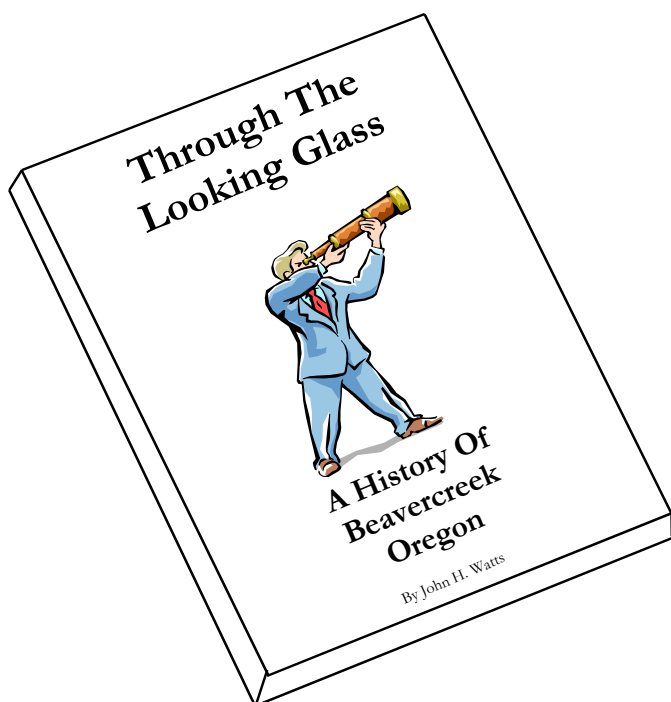

## Crime Stoppers Featured Case #15-32 - Fire Hydrant Tampering in Clackamas County

The Clackamas County Sheriff's Office, in cooperation with Crime Stoppers of Oregon, is asking for the public's help to solve several cases of criminal mischief involving fire hydrant tampering.

The Clackamas River Water District has experienced five incidents of fire hydrant tampering. These incidents have caused several thousands of dollars in damages as well as a boil water notices for thousands of residences.

The hydrants that have been tampered with are South of the Clackamas River and southeast of Oregon City in Redland/Beavercreek area, between June and August of 2015.

Crime Stoppers is offering a cash reward of up to \$1,000 for information, reported to Crime Stoppers, that leads to an arrest in this case, or any unsolved felony, and tipsters can remain anonymous.

Information learned from social media sites such as Facebook, Twitter or YouTube should be shared as these tips may lead to the identification of a suspect or suspects. Links can be shared anonymously through Crime Stoppers.

## Did You Know... Muscle Strength Fades After Just Two Weeks of Inactivity?

*(Excerpt from the August 2015 Wellness Update)*

A Study shows it takes much longer to regain lost power. It takes just two weeks of physical inactivity for those who are physically fit to lose a significant amount of their muscle strength, new research indicates. In that relatively short period of time, young people lose about 30 percent of their muscle strength, leaving them as strong as someone decades older. Meanwhile, active older people who become sedentary for a couple weeks lose about 25 percent of their strength. The more muscle a person has, the more they will lose if they are sidelined by an injury, illness or vacation, the Danish study found.

"Our experiments reveal that inactivity affects the muscular strength in young and older men equally. Having had one leg immobilized for two weeks, young people lose up to a third of their muscular strength, while older people lose approximately one-fourth. A young man who is immobilized for two weeks loses muscular strength in his leg equivalent to aging by 40 or 50 years," researcher Andreas Vigelsoe, from the Center for Healthy Aging and the Department of Biomedical Sciences at the University of Copenhagen in Denmark, said in a university news release.

Total muscle mass normally declines with age. Young men have about two pounds more muscle mass in each leg than older men do. But, after two weeks of not moving at all the young men involved in the study lost 17 ounces of muscle, on average. Older men, on the other hand, lost about nine ounces. However, all of the men lost physical fitness while their leg was immobilized, the study published recently in the Journal of Rehabilitation Medicine found.

"The more muscle mass you have, the more you'll lose. Which means that if you're fit and become injured, you'll most likely lose more muscle mass than someone who is unfit, over the same period of time," said Martin Gram, another researcher at the center, said in the news release.

"But even though older people lose less muscle mass and their level of fitness is reduced slightly less than in young people, the loss of muscle mass is presumably more critical for older people, because it is likely to have a greater impact on their general health and quality of life," Gram said.

After being immobilized for two weeks, the men who participated in the study trained on a bike. They worked out three to four times a week for six weeks. Although this exercise helped the men regain physical fitness, the researchers found their muscle strength didn't fully recover in that period of time.

"Unfortunately, bicycle-training is not enough for the participants to regain their original muscular strength," said Vigelsoe. "Cycling is, however, sufficient to help people regain lost muscle mass and reach their former fitness level.

If you want to regain your muscular strength following a period of inactivity; you need to include weight training."

Threemile Canyon Farms appointment are the following:

According to the Oregon Employment Department, between 2002 and 2007, at a time when Threemile was expanding dramatically, nearly half of Oregon's dairy farmers went out of business, on average 9 per month. The industrial, factory farm model of milk production taking place at Threemile has put small farms out of business across Oregon.

Threemile is likely the State's single largest source of agricultural air pollution. By their own admission, manure from Threemile releases up to 2850 tons of ammonia gas each year. According to the US Forest Service, this makes Threemile Canyon one of the biggest sources of haze and acid fog in the Columbia River Gorge. With over 50,000 cows in confinement, the operation produces twice the biological waste of a city the size of Salem.

Oregon is a State predominantly made up of small and mid-sized farms, with nearly 85% of Oregon farms owned and operated by families and individuals. In contrast, Threemile is one of Oregon's very rare massive-scale corporate farms, owned by a company from North Dakota.

Threemile Canyon Farms already has far too much influence over politicians and government agencies charged with regulating agriculture. The company has given \$90,000 to Oregon political candidates over the past three years, and has spent over \$178,000 on lobbying State legislators and the Governor's office since 2012. Whether it's gaining lucrative tax credits, the promotion of international trade deals for their own benefit, or maintaining Oregon's weak laws over large factory farms, the conflicts of interest with Threemile Canyon Farms serving in an advisory role to the Oregon Department of Agriculture are substantial.

Oregon's Board of Agriculture should be made up of family scale producers that broadly represent farmers across Oregon. Polluting, factory farm operators whose corporate headquarters are out-of-state, and who have significant financial conflicts of interest, should not have a seat on this Board. Take Action Today! ## Oregon City Police Participate in Safety Belt Blitz

The Oregon City Police Department Patrol Division participated in the third Safety Belt Overtime Campaign Blitz of 2015, which was conducted from August 24, 2015 through September 6, 2015. Officers focused on drivers failing to use safety belts, drivers using cellular phones, and speed enforcement. The officers issued a total of 101 citations and or warnings during this enforcement operation. The final stats for this operation included 14 contacts for failing to use

to help promote apprenticeship and work-based learning opportunities.

"At a time when many of our most highly skilled manufacturing workers are retiring, this grant will help us expand apprenticeship and work-based learning. Securing the grant was a collaborative effort between OED and the Oregon Bureau of Labor and Industries (BOLI) along with other partners and private sector employers. The result was the formation of a program known as Oregon-Apprenticeships in Manufacturing (Oregon-AIM).

The goal of Oregon-AIM is to build strong apprenticeship and work-based learning programs within the advanced

manufacturing industry. The grant will be used to aid employer recruitment and create innovative training, including online opportunities.

In particular, the program will strive to create apprenticeship training opportunities for women, people of color, veterans, Temporary Aid to Needy Families (TANF) and Supplemental Nutrition Assistance Program (SNAP) participants.

The Oregon Employment Department, along with employers Collins and Madden Industrial Craftsmen submitted the grant application. Other key partners include BOLI, 21 employers, three industry associations, the Office of Governor Kate Brown, Oregon Higher Education Coordinating Commission (HECC), Department of Community Colleges and Workforce Development (CCWD), and Department of Human Services.

## Federal Policy Update - Food Safety Modernization Act on the Way

The Food and Drug Administration (FDA) is expected to release its long-awaited Food Safety Modernization Act (FSMA) Produce Rules by the end of September. These new rules could have a major impact on family-scale vegetable and fruit producers and smaller food processors across Oregon. While proposed rules contain some exemptions that will benefit Oregon producers, many could face costly requirements that could threaten their economic viability while doing little to improve food safety.

In 2014 Friends of Family Farmers, FoFF, provided comments on the draft rules in an effort to protect smaller and mid-sized producers from onerous rules that would add costs and threaten farm viability, particularly for diversified

and organic producers. This summer, we met with Mike Taylor, Deputy Director of Foods at the FDA, as well as Oregon Department of Agriculture (ODA) food safety staff to discuss our concerns over the potential impacts to smaller and mid-sized farmers.

Once the rules are finalized this fall, we will be working with ODA to ensure that FSMA is administered fairly and that farmers with good food safety practices aren't put out of business by bureaucratic red tape and costly measures that have little impact on food safety. We are interested in hearing directly from farmers about concerns with FSMA implementation and enforcement. They will be on their own to make the replacement or repairs.

#### Land Use Decisions:

A proposal to partition a 4.27 acre parcel on Kamrath Road into two lots. The County approved the proposal with conditions.

A Temporary permit for care for a property on Henrici Road was approved by the County with conditions.

#### Land Use Activity:

The riding arena and horse boarding facility on Henrici Road that applied for a conditional use permit, after the structures was built and the business started, was approved by the County with conditions and time lines. It was later appealed by the owners to LUBA, where LUBA wrote in support of the County's decision. Code Enforcement is now involved and the owners now have a timeframe in which to get the problems remedied.

#### Land Use Response:

There was a response by the County to a question the Hamlet posed as to how the partitioning on parcels was determined when you take land consisting of 9.7 acres, zoned RRFF5 (Rural Residential Farm Forest 5 acre minimum), and partition it into two parcels where one parcel is 6 acres and one parcel is 4 acres. This equals 10 acres. A letter in response by Rick McIntire was read. Apparently 50% of the road front is figured into the equation.

Cheryl Boffard gave a Treasurer's report.

Christine Kosinski gave a Transportation Report. The Oregon City Planning Commission will hear the Beavercreek Road Concept Plan on Monday, November 9, 2015, at 7:00 p.m. The plan will be heard with no changes to the original plan which has caused a lot of testimony by concerned citizens who are not in favor because of a broad array of the issues. She says they will probably approve it anyway. The area will be a MUC Zone (Multiple Unit Corridor) the zoning allows building from a minimum of two stories to 60 feet in height. Also between the high school would be an Enterprise Zone. Companies who want to move into the one can do so with a 3-5 year tax abatement.

There was no new news from the Korner Park Committee.

The October elections were discussed. There is a slate of people running, all incumbents. The Board of County Commissioners want more citizen involvement. To that end a mailing is going out to all residents and business owners asking them to come to the October Town Hall Meeting and cast their vote.

The Movie in the Park summary was given by Bill Merchant. Since the weather was not conducive to having the event outside it was moved, at the last minute, to the Beavercreek Grange. There were various issues that arose and Mr. Merchant was not happy about the outcome.

## Where Are The Boundaries of The Hamlet?

If approved by the Public Utility Commission of Oregon (PUC), residential customer rates will decrease by almost 7% starting Nov. 1.

This means customers will pay less for natural gas than they did 15 years ago.

"This is good news for customers," said Randy Friedman, director of NW Natural gas supply. "The cost of natural gas has continued to drop this year and is expected to remain low for the next few years."

### **What customers can expect**

The filing calls for a 6.9% drop in residential rates and a 7.6% reduction for commercial customers. That means the typical residential customer using an average of 53 therms per month would pay about \$4.24 less, and the typical commercial customer would pay \$17.97 less per month.

The proposed rate reduction is in addition to the \$9.6 million bill credit that NW Natural passed back to Oregon customers in June, which was a result of efficient use of storage and pipeline facilities.

### **What we filed**

On Sept. 15, NW Natural filed a proposed rate adjustment with the PUC which reflects lower projected natural gas commodity prices for the coming year, as well as other year-to-year adjustments and costs approved by regulators.

The primary factor in this year's rate reduction is the decline in wholesale gas prices thanks to an abundant domestic supply of natural gas. Also factored into this year's rates are the costs of using additional storage capacity at NW Natural's Mist Storage facility and recovery of environmental clean-up costs related to legacy manufactured gas plant operations.

Regulators will issue a final decision on rates by the end of October, with new rates effective Nov. 1. Find more information in the Rates & Regulations section of [nwnatural.com](http://nwnatural.com) or call 503.226.4211 and ask for the Rates & Regulatory Department.

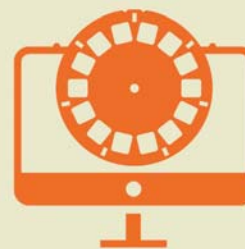

## Oregon City Man Critically Injured in Hwy 26 Crash

On September 23, 2015 at about 8AM, OSP Troopers and emergency personnel responded to the report of a crash involving two motorcycles on Highway 26 near milepost 32 (east of Sandy).

Preliminary information indicates, Marc R GIBSON, age 65, of Oregon City was operating a 2014 Harley Davidson motorcycle eastbound on Highway 26 when he drifted left and struck the center cable barrier. GIBSON was thrown from his motorcycle onto the highway.

Vernon HENDERSON, age 68, of Clackamas was operating a 2010 Harley Davidson and was following GIBSON when he crashed. HENDERSON was unable to avoid GIBSON's crashed motorcycle and struck it. HENDERSON was thrown from his motorcycle onto the highway.

GIBSON was taken by air ambulance to Legacy Emanuel Medical Center for life threatening injuries. HENDERSON was taken by ground ambulance to Legacy Emanuel Medical Center for minor injuries.

The eastbound lanes of Highway 26 were closed for two hours while the scene was investigated. Traffic was re-routed for eastbound traffic. OSP was assisted on scene by the Oregon Department of Transportation, the Clackamas County Sheriff's Office, Hoodland Fire District and American Medical Response.

The investigation is ongoing and more information will be released when it is available.

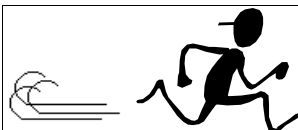
