VFW Provides Computers to Link Families With Deployed Army National Guard Soldiers

The National Guard has received its first four Gateway laptop computers to allow video conferencing between a soldier in Afghanistan and his/her family in Oregon/Washington. These internet-ready, web-cam equipped machines were delivered by Burt Darnielle, Military Assistance Chairman for the VFW, Department of Oregon.

Accepting the first computer is Michelle Stanley, Battalion Coordinator for the 41st Special Troops Battalion stationed in Afghanistan and Major Mote, the Commander of the 41st Special Troops Battalion. Also present for the occasion were Dan Wakefield, VFW Department Commander, and Wayne Sharp, Quartermaster, of the OR VFW and Betsy Kingsbury, the Family Assistance Specialist at the Family Center at Camp Withycombe.

Two of these laptops will be sent to Camp Phoenix in Afghanistan for the soldiers to use and the other two will be placed in Oregon for the families to use. One is located at the Camp Withycombe Family Center in Clackamas OR. If you are presently in communication by letter, e-mail or phone with a deployed soldier and would like more information on how to videoconference, please call Betsy Kingsbury at 503-557-5339, Monday through Thursday.

The Oregon VFW has been very active in supporting deployed troops and their families. Burt Darnielle said there are now 404 of these computers on loan nationwide - an effort designed to help military families connect with deployed soldiers through e-mail and video-conferencing. Michelle Stanley said that she was sure many National Guard families, especially those without computers or video cameras, will be excited to actually see their child, spouse or parent using this new equipment. She said, "We are very grateful to the VFW for their generosity in recognizing this need."

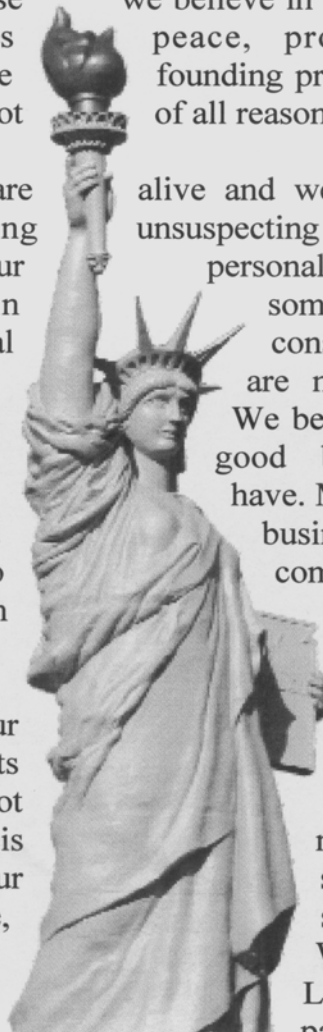

"Beavercreek Oregon a History Through the Looking Glass"

This is Part XLIX of a series of articles on the history of the Beavercreek area. Written by Jack Watts, whose family were some of the early settlers of the community. This history is reprinted from his original manuscript that had until now never been published, by permission of Gordon Watts. terian Church and to provide space for a burial ground in the Beaver Creek neighborhood. The transaction is recorded as of November 27, 1888, in Book 32 and Page 187.

Because of an error in locating the one-acre plot, either the church was built or perhaps graves were opened and interments made in what proved to be the wrong acre of land. In this way the cemetery was located on land belonging to Mr. Thomas Daniels, which adjoined the property of Mr. and Mrs. Elias Edwards. When the error was discovered, Mr. and Mrs. Daniels graciously agreed to donate that acre of land to the Presbyterian Church, making it a two-acre tract of land.

No date was shown as to when the church was actually built, but the first record of any activities in it is recorded under the date of June 11, 1893; the records show that the officers were:

The question arose as to whether the error in locating the original site had caused the County to layout what is now known as South Kamrath Road somewhat west of a straight line south to the cemetery property. In the meantime, the First Presbyterian Church had ceased to function at an undisclosed date, with the site used exclusively as a cemetery.

On March 11, 1888, a deed recorded in Volume 64 and Page 371 of Records and Deeds for Clackamas County, Oregon, was turned over to the Cemetery Association which had been formed with Mr. Edward Hughes, Mr. David Harris, and Mr. R. M. Cooper as Trustees that portion of the land in the cemetery that recent surveys had shown to be on his land. In May of 1935 a motion was made, seconded and carried to have the Trustees authorized to have the cemetery plotted and to provide records of individual burial plots. Mr. Hal Rands was hired to survey the property; and he states, "I am advised that the Presbyterian Denomination has given a quit claim deed of the Church property to the Cemetery Association, but apparently same is not

A meeting held on May 30, 1925, of the Beaver Creek Association was called to order by Mr. David Harris, Chairman, at 12:30 PM. After the reading of the minutes, it was decided that the Board of Trustees be empowered to make legal arrangements by which this institution shall hereafter be known as the Beavercreek Cemetery Association. On June 10, 1937, a discussion was held concerning the advisability of disposing of the church building, when a motion was made by Mr. E. O.

Hunters Advised to Avoid Wildfire Areas

Before heading afield, hunters are advised to find out if there are any large wildfires in their hunting areas.

Currently, the map of Oregon is dotted with large fires and fire complexes. For their own safety and to avoid impeding firefighting operations, hunters would do well to avoid the sites of major fires, the Oregon Department of Forestry announced today.

Often, forest roads around a wildfire are closed to the public. And even on roads that remain open, hunters may encounter firefighting vehicles.

The location of active wildfires in the state can be

found on the Northwest Interagency Coordination Center's website, <http://www.nwccweb.us/>.

For specific information on forest road closures and other restrictions on public lands, hunters should contact the natural resource agency with jurisdiction. Many popular hunting sites are on lands managed by the U.S. Forest Service or the Bureau of Land Management. Their local offices will have up-to-date information on access. For fire information on private and state-owned lands, contact the local Oregon Department of Forestry office.

Those planning to hunt on private lands should check on access. Many privately owned forestlands across the state are closed due to fire danger.

The cool nights make a campfire or a warming fire inviting on a hunting outing. But after use, a fire should be completely extinguished. Otherwise, it can rekindle later in the day as the weather warms up and become a wildfire.

Foot Bridge Over Clackamas River Burns

Monday August 14th, 2006, Clackamas County Fire District #1 and Gladstone Fire Department responded to a reported brush fire at 02:40 a.m. When fire crews arrived they found flames shooting 40 feet in the air surrounding the foot bridge between Oregon City and the City of Gladstone just below High Rocks above the Clackamas River. Crews quickly requested additional resources to include 7 fire apparatus. The fire engulfed one end on the bridge and the adjacent brush.

The flames and heat damaged the bridges heavy timber posts, beams and decking. The fire was deemed under control within 1 hour. Crews remained on scene until 07:30 ensuring that all of the hot spots were out. Complications to this fire included the bridge decking burning under the 2 inch thick asphalt roadway. Crews had to use specialized cutting saws and pry bars to expose the heat and flames.

The cause of the fire is still under investigation. No in-

juries were reported and the foot bridge is closed to all pedestrian traffic.

These types of fires spread quickly and can be very dangerous. Please call 911 immediately to notify emergency responders.

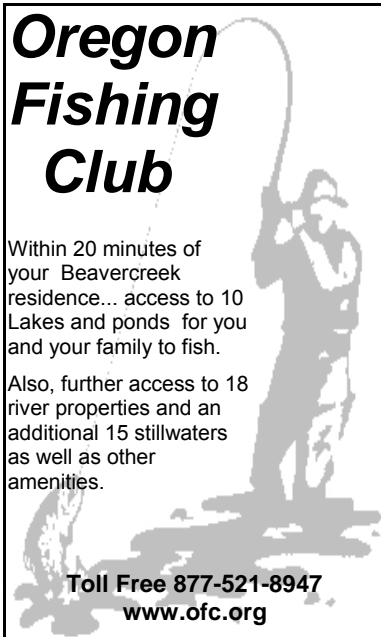

John R. Shaver Building Dedication Ceremony Held August 16th

The Clackamas County Sheriff's Office John R. Shaver Building Dedication Ceremony was held on August 16, 2006, from 10:00 a.m. to Noon. The Shaver Building is located at 256 Warner-Milne Rd., Oregon City.

Special Guests: Sheriff Craig Roberts who was the emcee, Undersheriff Charles Bowen, Clackamas County Commissioners (tentative), and three descendants of Sheriff John R. Shaver -- including Tammy Shaver, a current operations supervisor at Clackamas County Central Communications (CCOM); Alice Shaver, age 92; and Richard Shaver, a newly appointed Wal-lowa County surveyor.

The Shaver Building is named for Clackamas County Sheriff John R. Shaver, who died in the line of duty in Woodburn on April 30, 1906. According to the Officer Down Memorial Page (odmp.org), Sheriff Shaver "was shot and killed while attempting to arrest Frank Smith, the suspect wanted for murdering Officer George Han-lon, of the Oregon City Police Department, one week earlier." Oregon Army National Guard Captain O. D. Henderson, commander of the National Guard unit in Woodburn at the time, was also killed during the arrest attempt.

Frank Smith was pursued by a large posse, and killed several days later by Harry Draper of Spokane, who collected \$750 of the \$1500 reward.

According to genealogy Web site GessWhoTo.com, Shaver is "one of only eight Sheriffs in the state to be killed in the line of duty."

In other words, it brings people together who should be working together, so we can use their talents as a team, to better serve the citizens of Clackamas County," stated Sheriff's Lt. Debbie Brent.

The Sheriff received the Shaver Building deed from the previous tenant, the federal government, on Feb. 5, 2004. From there, the Sheriffs remodeled the building in two phases:

Phase One: The IRS left the building and a partial Sheriff's Office remodel was completed in early 2005.

Phase Two: On March 31, 2006, the remaining federal tenants moved out so remodeling could be completed. Final renovations were finished in July 2006.

Two Homeland Security grants allowed the Sheriff's Office to upgrade building security (including a fence and alarm system) and install a generator that can power the building during crisis situations.

Clackamas County and the Sheriff's Office also provided funds for the building remodel. A remodel that included moving and knocking down walls, upgrading

the electrical system, bringing the building up to current code standards and furnishing the building.

Other new features include a conference room, a break room, and two new interview rooms with recording capabilities.

It should be noted that the Shaver Building is not a public reporting station. In other words, it is not designed for walk-in citizen traffic. 90-Day Log Brand Renewal Period Begins October 2

The Oregon Department of Forestry (ODF) reminds timber operators with currently registered state log brands that they must renew their log brands between October 2 and December 31, 2006.

To ensure receipt of a renewal form, timber operators whose addresses have changed since their last registration/renewal should send their current address to the Oregon Department of Forestry's Log Brands Unit before October 1, 2006.

Log brands discourage log theft

Log brands - the identifying symbols welded onto the face of a hammer and struck into the ends of logs for identification - discourage log theft and aid in the return of lost logs. When transported on public highways, waterways, or railroads west of the crest of Oregon's Cascade mountain range, forest products and booming equipment must be impressed with a log brand, registered strictly through the Log Brand office in Salem.

Renewal forms will automatically be mailed to registered log brand owners on October 2, 2006. These log brands will be good through December 31, 2011. Any log brands not renewed will be considered abandoned,

and the registration number will expire at that time.
