July Town Hall Meeting Recap

Sergeant Clint Pierce with the Clackamas County Sheriff's Office presented on the crimes and complaints statistics in the Beavercreek area. He also described some of the intricacies of the trespassing exclusion program.

Katie Wilson, the Hamlet's Staff liaison with Clackamas County, provided County updates. Bill Merchant commented that he hasn't received any updates on the Beavercreek Road Repaving Project and requested a response from Clackamas County after numerous inquiries. Katie suggested using social media, especially Twitter, to receive updates. The Carus CPO postcard mailer has not yet been mailed because it needs to be paired down and clarified. She informed the members that the Korner Park is not a "tax foreclosed property" as some had thought, as the DEQ gave the property a clean bill of health. Ken Humberston also provided an update on the activities he's involved in including a brief ClackCo "budget 101." A member asked for an update on the proposed speed light near Oregon City High School that would flash during school hours, which Tammy Stevens provided. Another requested the name of the Korner Park be renamed through the ongoing Korner Park discussions.

Land use application Z0291-19 was presented. Jason Pompel moved to approve in support. Jack Hipp seconded the motion and the public voted seven in favor, none opposed, and none abstained. The board voted six in favor with none opposed and one abstained.

1-205 Closures in August

There will be a 24/7 full weekend closure of I-205 north from Foster Road to the I-84 interchange from 10 p.m. on Friday, August 2 to 5 a.m. on Monday, August 5. Also closing will be three on-ramps (Sunnyside/Sunnybrook, Johnson Creek Boulevard and Glisan Street) to I-205 north outside of the closure area starting at 9 p.m. on Friday, August 2. They will re-open at 5 a.m. on Monday, August 5.

There will also be a full closure of I-205 in both directions over the Glenn Jackson Bridge for up to several nights in mid-August 11:59 p.m. to 5 a.m. Exact dates are not yet available. Construction crews will install sign bridges on the south end of the bridge for new ODOT RealTime signs. I-205 will close to traffic between Portland, OR and Vancouver, WA during the closure. Planning Commission will hold its first public hearing regarding the adoption of Ordinance Number 19-1010 (Planning File LEG 19-00003) to consider proposed Code and Map amendments, and any applicable ancillary document revisions. The City Commission will hold public hearings to considering the adoption of Ordinance Number 19-1010 once the Planning Commission has made a recommendation. All meetings will be held at Oregon City, City Hall, 625 Center Street, Oregon City at 7:00 pm unless otherwise noticed. Any interested party may testify at the hearings or submit written comments at or prior to the public hearings while the record is open.

All hearing materials are available at www.orcity.org seven days prior to the public hearings. The Ordinance, Code changes and Map amendments are available at the Oregon City Planning Division (698 Warner Parrott Rd). It is anticipated that these documents will be revised during the review process until final adoption by the Oregon City City Commission. Additional information may be

found by calling (503) 722-3789.

The purpose of this project is to update the Comprehensive Plan and Oregon City Municipal Code (OCMC) to allow planned housing and mixed-use development to occur, including applying mapping and zoning designations for properties within the Concept Plan Area. No annexations are being proposed as part of this action.

What are the Products of the Implementation Project?

- * Adoption of Comprehensive Plan Map designations for the properties within the BRCP area.
- * Adoption of Zoning designations for all properties within the city limits.
- * Adoption of any needed development amendments to the Oregon City Municipal Code to implement the BRCP.
- * Adoption of any needed revisions to adopted master plans or other ancillary city documents needed to implement the goals of the BRCP.

Oregon DHS Recruiting for More Than 300 New Jobs

The Department of Human Services (DHS) this week posted openings for more than 300 jobs related to helping children and families in Oregon. "These new hires will reduce caseloads, which will help us better address safety issues and provide more support to foster families," DHS Director Fariborz Pakseresht said "An influx of new staff also will provide much-needed relief to our current child welfare caseworkers and help reduce turnover."

Some of the jobs available include:

- * Hotline Screener Screeners are the first responders to reports of safety concerns. Screeners determine appropriate levels of response and interventions including protective, family support and other community services. Our hotline receives more than 600 calls during an average 24-hour period.
- * Child Protective Services Child Protective Service caseworkers investigate reports of safety concerns for Oregon's children and families. This includes conducting child safety assessments of alleged child abuse or neglect, evaluating whether a child has been or is currently at risk of being harmed and, if needed, determining appropriate services to ensure child safety.
- * Certifier Certifiers work to identify and certify relative caregivers, foster parents and adoptive parents across all ethnic and cultural groups. This work includes home studies, interviewing and evaluating appropriateness of substitute care placements when children are unable to live safely at home.
- * Permanency Worker Permanency caseworkers specialize in working with children, families, foster parents and caregivers to ensure children are safe in their homes. This includes assuring a child's physical, psychological and social well-being with the goal of reuniting families or finding alternate, permanent plans when necessary.

Clackamas River Boating Closure

The Oregon State Marine Board closed a portion of the Clackamas River to recreational boating in the vicinity of the PGE Faraday Powerhouse due to the construction of a new powerhouse. The in-water use of heavy machinery poses a significant safety risk to boaters. This temporary rule (OAR 250-020-0033) prohibits boat operations near the Cazadero dam to a point 100 feet downstream of the PGE Faraday Powerhouse, a distance of approximately 1.8 river miles. Signage is posted at nearby ramps and buoys cordon off the downstream end of the closure area. This rule will remain in effect until January 1, 2020. Unemployed Homeowners Mortgage Payment Assistance

Oregon Housing and Community Services (OHCS) is pleased to announce that the Oregon Homeownership Stabilization Initiative (OHSI) is re-opening a mortgage payment assistance program for Oregon homeowners receiving unemployment benefits.

The Mortgage Payment Assistance
Unemployment program (MPAU) is designed to help unemployed homeowners avoid foreclosure while they seek new employment. Eligible homeowners may receive assistance

to cover up to 12 months of mortgage payments, up to a maximum of \$20,000.

Basic eligibility requirements of the MPAU program include:

- Applicant is receiving unemployment insurance at the time of application
- Applicant does not own other residential property
- Applicant is not in active bankruptcy

Applications will be accepted until September 30, 2019. Interested homeowners should visit www.oregonhomeownerhelp.org for information on the application process including an eligibility checklist, application document checklist, and FAQs.

To date, OHSI programs have provided over \$265 million to help over 15,000 Oregon homeowners stay in their homes. OHSI offers several other programs to help struggling homeowners including:

- Help for those on a fixed income struggling to pay their mortgage
- Help with property tax payments, including those with a reverse mortgage
- Help with past due mortgage payments for those who can demonstrate they can pay their mortgage post-assistance.

Veterans' Affairs Announces Rate Decreases on Home Loans

The Oregon Department of Veterans' Affairs has announced lower interest rates for its home loan products. The rates for Qualified Veterans Mortgage Bond (QVMB) loan products were lowered by 0.125 percent, while the rates for Unrestricted loan products dropped 0.250 percent. The rates took effect July 17.

The Oregon Veteran Home Loan Program, which provides the state's veterans with one of the most unique veteran benefits, has been one of ODVA's core veteran services since the agency's inception nearly 75 years ago.

Fall activities are critical for good forage next spring. Follow these steps to improve your pasture

- 1. Leave 3-4 inches of stubble in the fall! This allows grasses to store food for next spring.
 - 2. Take a soil sample. September is the best time to look at soil nutrient levels.
 - Apply fertilizer based on the results of your soil test.
 - 4. Scout for weeds. Fall is a good time to pull or spray annual weeds.

One-Ring Phone Scam: What to Know

It seems like most of us get those annoying calls from telemarketers and scammers these days. Your phone rings and rings and rings. Often, these are calls come from a lovely robotic voice informing you that you "missed an important payment." Or, perhaps, the voice on the other end of the line is congratulating you on that "expense-free vacation" that you just won. In both scenarios, the scammer will try to get you to pay money to settle the non-existent debt or to pay for a small processing fee for that free trip. Later you discover later that you were taken.

While these kinds of telephone scams are not new, our friends at the Federal Trade Commission (FTC) are warning the public about a new variation that is popping up across the nation. It's called the "one-ring" scam. Here's how it works: you get a phone call from a number you do not recognize, and then the call drops after only one or two rings. The fraudster is counting on your curiosity – and maybe fear that the call you missed is really important. The goal is to get you to call the number back because, in reality, the scammer is calling from an international toll number. If you call back, you will likely receive per-minute toll charges ... and who do you think collects those funds? You are right if you guessed the scam artist.

So what can you do to avoid being a victim of this scam?

- * Do NOT call back numbers that you do not recognize, especially those that appear to come from overseas.
- * If you have received these calls, report the number to the FTC at www.donotcall.gov
- * Frequently check your phone bill for unusual or suspicious charges

As always, if you have been a victim of an online scam, report it to the FBI's Internet Crime Complaint Center at www.ic3.gov or

call your local FBI office.

County Adopts FY 2019-20 Budget

Last week, commissioners formally adopted the 2019-20 budgets. The action followed a series of public meetings and hearings by the county's budget committee in late May and early June.

The adopted general budget for #ClackCo is about \$863 million, including reserves. When adding in the adopted budgets and reserves for county-governed districts and agencies, such as Water Environment Services and the North Clackamas Parks and Recreation District, the all-adopted budgets total approximately \$1.22 billion.

CCC Offers Ireland Study Abroad Experience

This fall, Clackamas Community College is offering a study abroad trip to Ireland. Students and community members who take one of three classes will end the term with a trip Dec. 6-18, where they will learn about Irish history, ancient Celtic stories, Viking invasions, the Great Irish Famine and Irish emigration to the United States. On the trip, students will discover the importance of Ireland's borders in Brexit negotiations and see the Book of Kells at Trinity College in Dublin. They will also visit the O'Donnell Castle and Abbey in Donegal, hike the Sliabh Liag Cliffs, visit Yeats Country in and around Sligo, tour the Bloody Sunday Museum and Bogside Murals in Derry, and shop the Belfast Christmas markets.

Community members can participate in the study abroad experience without earning credit by registering through community education at www.clackamas.edu/workshops.

Click on "Cougar Trax," select "Community Education," search "Ireland Workshop" and register.

Cost of the trip is \$3,300, which includes airfare, accommodations, passport, course fee, most meals, course-related excursions and travel insurance. CCC tuition is separate from the price of the trip, but all financial aid applies for study abroad classes. Some additional small fees may apply. Workplace Safety, Health Training Grants

If you have a dazzling idea for a workplace safety or health training program, Oregon OSHA wants to hear your pitch. The agency is accepting grant applications for the creation of innovative on-the-job safety and health training programs. Applications are due by 5 p.m. Friday, Oct. 4. Oregon OSHA encourages unique projects such as mobile apps, videos, or online educational games to engage workers.

The training grants will focus on programs that target a high-hazard Oregon industry, such as construction or agriculture, or a specific work process to reduce or eliminate hazards. Any employer, labor group, school affiliated with a labor group, or nonprofit organization may apply. Applicants may request up to \$40,000 per grant project. Employers are not allowed to use grants to pay for training for their employees. Materials produced by grant recipients become the property of Oregon OSHA. Many of the materials are housed in the Oregon OSHA Resource Center and are available for use by the public. Some materials are available electronically.

Some examples of past grant projects include: Spanish-language flip charts designed to help prevent heat-related illness among forest workers; creation of safe design guidelines for anchoring systems used as part of logging operations; and an educational program for nurses to prevent ergonomic-related injuries.

The Oregon Legislature launched the Occupational Safety and Health Education and Training Grant Program in 1990. Award recommendations are made by Oregon OSHA's Safe Employment Education and Training Advisory Committee, a group with members from business, labor, and government.


